Vault to host volunteer expo

The Vault Cultural Collective is hosting an expo to both celebrate and recruit volunteers within the local community during National Volunteer Week.

Every April, National Volunteer Week is recognized nationwide, and is an occasion lead by Volunteer Canada. This year, it will take place from April 14 to 20.

"That is a focus week of celebrating volunteers, and so we are going to host a volunteer expo at the Travelodge (on Wednesday, April 19) from 4 p.m. until 7 p.m." said Donalda Ledene, vice chair of the Vault Cultural Collective. "(We want) to give the community at large an opportunity to see where we need and can use volunteers, and what organizations in the community are already volunteer led, where volunteers are putting a lot of time in, and to let the community see what would be missing from our community if we didn't have volunteers doing these jobs."

Ledene added the Vault was able to secure a grant in order to aid in facilitating the event, which was created with the idea in mind to help reinforce existing volunteer numbers, as well as to replace those who are no longer interested, or no longer able to be of service.

Overall, she estimated a total of between 15 and 20 volunteer and nonprofit organizations will be present for the expo.

"We are aware of many organizations whose volunteers are getting older and their membership is declining, and there are not younger people picking up the opportunities to be involved in the clubs," she said. "If volunteers are not there, these things are not going to get done ... we have reached out to all the nonprofit organizations and clubs in the community – people who operate fairly significant programs and services within the community."

Town councillor launches charity challenge

The Town of Strathmore's Coun. Richard Wegener is hosting his third annual charity challenge, this year being in support of the Wheatland and Area Hospice Society.

Similar to the previous two years of the challenge, Wegener has committed to matching the first \$1,000 of donations made to the subject nonprofit organization over the course of the month-long challenge.

"I feel like I am lucky to have my job on council and wanted to give back to the different charities around town," he said. "I figure if I host a charity challenge each year, I can bring awareness to these different charities and it is a way that I can give back to the community that has given me so much."

Coun. Wegener explained his reasons for selecting the Hospice Society are largely of a personal nature. He currently holds a seat as part of the Wheatland Housing Management Body, which is currently aiming to get a new lodge built in conjunction with the Hospice Society.

Additionally, he said his mother recently passed away while in palliative care at the Strathmore hospital.

"Knowing that and the care she got there, I wanted to relate that to the hospice care. They look after what they call (people's) end of life journey," he said. "My mom was treated so well at the hospital in palliative care, and for me it is just a next step to hospice."

This year's challenge will run from April 1, until May 5, coinciding with the date of the Hospice Society's Hype for Hospice and Fire Truck Pull event.

Coun. Wegener said he has been excited and impressed by the response to the charity challenge from the local community over the past two years, both times during which, the \$1,000 goal was exceeded.

"The first year, I did it for the overnight shelter and I think along with my donation, we raised close to \$3,000 in the month. Last year was the food bank and we raised quite a bit of money – it was just hard to get an accurate tally on that because of the online donations and everything," he said. "I think the community is behind it; I always try to do something that is a worthwhile cause for both people in the town, but also in the county – people who need these services."

To donate online, those who are interested are able to do so at www.wheatlandhospice.ca through the GoFundMe link. Those who donate are asked to email or text Coun. Wegener (403-325-5080, rwegener@telus.net) to specify how much they donated for the final tally.

He added because the donations are going to a nonprofit organization, donors will be able to claim a receipt for the purposes of their taxes.

Strathmore to host fifth annual festival

This year marks the fifth annual Strathmore Performing Arts Festival (SPAF) beginning April 10 and running steadily through to April 24.

Last year's festival had 141 participants with this year on track to be the biggest participant turn out yet.

Loralee Laycock is the current president of the SPAF and she is excited about the upcoming festival.

"This year, we have a week and a half of classes being offered," said Laycock. "We have classes in string, choir, speech, contemporary and classical voice, and musical theatre and then we have six days of piano. In addition, we have instrumental and band running simultaneously. In other words, we have a lot going on and lots to see."

This year Laycock is excited about the number of entrants for the contemporary voice category, which is happening on the evening of April 11.

"That's kinda a fun category. People get to sing with a microphone ... they can use different types of accompaniments other than just piano," she said. "They sing popular music, country music, faith-based music and that's also the night of our family class, which is always a big hit too."

The fundamentals of the SPAF is to encourage the arts in and around Strathmore by providing a safe and positive environment for everyone involved – audience members, adjudicators and performers alike. The festival is primarily for elementary, junior high and high school students from the immediate area.

"We have so much community support," said Laycock of the tremendous sponsors who have generously donated to the festival. "We appreciate every dollar we receive that helps go towards running the festival. In addition to sponsors, other ways we see community support is through the volunteers that come to help run the festival. Our board is Laycock said each session requires two volunteers. Last year there were upwards of 40 volunteers for the festival and this year they are looking for the same. The festival is capped off with the final concert on April 24, which is always a huge draw for people.

"Everyone wants to come to the final concert, see the outcome of everyone's hard work," she said.

This year's final concert is generously sponsored by Carey Rose, RE/MAX Key with an admission of \$5 per person or \$10 per family and can be purchased at the door.

"I would love to encourage more people to come to more of the (daily) sessions," said Laycock. "This year admission is by donation only."

"We would really love to see more people attending the daily sessions. Having more people in the audience encourages the performers and helps them feel like they are performing to an audience," said Laycock. "This is a great way to support the community and support the young people who are trying to pursue their passion in music."

County committee opens final 2024 budgets discussions

An update regarding Wheatland County's operating and capital budgets was presented by administration to the Committee of the Whole, during the March 28 meeting.

The presentation included a summary of the changes that have been made to the 2024 interim operating and capital budgets, which are to be included in the draft of the final 2024 operating and capital budgets.

The final budgets were presented to council during the regular meeting, which took place April 2.

"What we typically do is, around August we start doing our plans for the next year with management and putting together capital and operating budgets ... and within our software, compiling all that together," said Joel Chiasson, manager of financial services with Wheatland County. "Then we usually have meetings with council around November (or) early December and deliberate, provide a lot of substantial details on specific capital projects and the operating budget, and that is the point then a lot of the operating plans and the capital plans for the upcoming year are put in place and approved by council."

Final capital and operating budgets are looked at and approved at the end of March and the beginning of April annually, in preparation for the

remainder of the capital year.

Also observed is the income from property taxes, which he explained accounts for roughly 70 per cent of the county's income.

"The main reasons or the focus of this period of time, is it gives an opportunity for any material changes to expenditures; anything that has maybe been approved by council in a resolution in that in-between term as an increase can be thrown into the budget, whether it is a capital or operating item," said Chiasson.

County council approved the 2024 interim operating and capital budgets on Dec. 19. The draft of the final 2024 budgets has been amended in order to reflect the 2023 property assessment values, final school requisition, and a host of other changes.

The drafted document suggests operating expenses for the county at \$54.13 million, being an increase of \$1.59 million from the 2023 budget.

Similarly, the drafted final capital budget reflects a \$1.91 million increase from the interim budget. Of this increase, \$0.95 million is accounted for via incomplete, but approved projects carried over from 2023 to finish in 2024. Another \$0.84 million is from an approved land purchase transaction that was completed in Q1 2024.

More information regarding the drafted final budget is available through the Committee of the Whole meeting recording, as well as via the public meeting agenda.

County discusses new ward boundary

Wheatland County administration provided a report to the Committee of the Whole regarding their prior questions about the Electoral Boundaries Bylaw review.

The report was created based on previous discussion at the Feb. 13 committee meeting, as the committee's questions were noted and summarized.

During the Feb. 13 meeting, the committee was presented with four options for possible electoral boundary adjustments.

Population growth within the county warrants the occasional necessity to redraw the boundaries of electoral wards based on the number of people who live in each area.

This is to ensure population variances between any respective ward is less than 25 per cent, and that as many county residents as possible are accurately represented on council.

According to administration, redrawing boundaries can also reflect both current, as well as future population trends, while adhering to legislative requirements.

Desired outcomes for the redrawing of boundaries include equitable distribution of representation, boundaries that accommodate current growth and future development, and to establish a bylaw that is in line with the generally accepted rule of a roughly 25 per cent population variance.

"It is ideal to have a balance between rural and urban sections in a division, but sometimes that just can't occur into that division, and that is something we would just need to take into consideration as it goes forward," said Brian Henderson,

Legislative requirements of drawing ward boundaries are outlined within the Municipal Government Act, which governs much of the powers, regulations, and responsibilities held by the county.

A report previously provided by administration to the county indicated an an average of 525 residences per division, with the greatest discrepancy being between Divisions 5 and 7 – which had 742

As boundaries are being redrawn, ultimately the focus is less about the total land area which each ward occupies, and more so is focussed to reflect population numbers and density.

The last time ward boundaries were redrawn within the county was in 2001. The timing of the boundaries to be redrawn this year also takes importance with a county election scheduled to take place in 2025.







Town authorizes conditional payment to WHMB for Wheatland Lodge

The Town of Strathmore authorized the payment of \$463,389 for design work on the Wheatland Housing Management Body's (WHMB) proposed 120-unit Wheatland Lodge.

This payment is aimed to help get the project to a "shovel ready" status for application to a provincial granting program. The funds approved to finance the payment are to come from the town's financial stabilization fund.

It was specified that the transfer of those monies is contingent on all other funding partners for the project authorizing payment of their proportionate shares of the design work.

The request was clarified to council to not be for monies additional to the initial project budget, rather, it was a request for a portion of the initial project budget in order to complete design work, such that the project is shovel ready, prior to the province's affordable housing partnership program intake for capital funding requests this fall.

"The \$463,389 currently requested would be within the capital requisition of \$566,625, variance on which is only subject to the evaluation of the townowned lands to be donated as the proposed lodge site as part of the town's contribution," said Kevin Scoble, chief administrative officer with the Town of Strathmore. "Typically, the province either requires or more highly prioritizes shovel-ready projects, and that is our understanding of the WHMB's request ... is to take that to that shovel ready, to improve the prioritization by the province in awarding money."

Mayor Pat Fule stressed the fact that the money being requested by the WHMB is strictly part of the \$566,625 previously approved by council for the project in April 2023, contingent on other factors, and is not an extra mothe province for support, and a contribution in the amount of \$7,140,000. The awarding of this grant is one of the conditions set out by the town as a contingent of their support.

According to information presented to council by administration, provincial funding for seniors housing has become expected to increase significantly, though with an impetus on shovel-ready projects.

The WHMB is aiming to advance the hospice building from a Class B Budget to a Class A budget, for which they are requesting contributions from all of their funding partners, totaling \$1.4 million.

A Class B Budget is prepared when channel.

a project is at a "detailed design" stage, which is defined as having a finalized space program, as well as having the drawings and specifications for all disciplines complete to 99 per cent. At this stage, addendums to clarify certain aspects of the project may still be issued.

A Class A Budget refers to an estimate attained when the bids for a project have been received, evaluated, verified, and the award of the development contract has been made.



Here's another reason why men might want to consider stopping smoking. Smokers are more likely to develop male-pattern hair loss. Researchers reviewed the data from observational studies of 4462 men and found that compared to men who had never smoked, smokers were 82% more likely to develop hair loss.

Strathmore Soccer aims to launch adaptive needs program

The Strathmore Soccer Association (SSA) recently hosted an event at Crowther Memorial Junior High in order to train more local coaches.

"Over the past two years or so, Strathmore Soccer and myself have been working on developing an adaptive needs program, as per the directive set forth by Canada Soccer," said Ryan Parkin, technical director with the SSA. "There is not a whole lot of tangible resources in place yet, so what we have done is we have worked with partners at Soccability Canada, and they were able to deliver a training program for us that will help us develop what we are hoping to deliver as a pilot, starting hopefully in May."

Parkin described it as being effectively a program dedicated to defining how Strathmore Soccer would run a program.

This would include coverage surrounding how other similar programs are operated, key terminology, and other particulars associated with running an adapted program.

The second half of the day, he explained, would be dedicated towards practical exercises where community kids will be brought in who might fit the adapted program.

SSA and Soccability Canada are working towards creating and the eventual launch of a soccer program in Strathmore focusing on developing an avenue to play for people with disabilities and/ or special needs.

"We as an organization have a mandate of trying to make this as accessible as possible to all members of the community," said Parkin. "What this enables us to do is obviously provide quality programming for individuals that our current programs just don't facilitate the needs for."

The event which took place at Crowther Memorial, Parkin explained, was an amalgamation of the coaches within the SSA who will potentially be running the new adaptive needs program upon launch.

Members of the local community who aided the SSA in connecting with kids who may be able to benefit from adaptive needs programming also participated in the training session.

Parkin estimated a minimum of six coaches will be required to run the initial pilot of the adaptive needs program, with more or less demand which will be dictated by community interest.

"So far, the response has been very positive," said Parkin. "Obviously, it is still very new, so people are still trying to understand what we are trying to offer, as well as what they can expect ongoing from delivery."

More information about the program is available through the Strathmore Soccer Association website. The adaptive needs program is estimated to be able to launch this coming spring.

Chariots of Fire to open Rosebud Theatre season

Rosebud Theatre opens its 2024 season, April 5 to May 25, with Chariots of Fire, the story of two runners who competed in the 1924 Paris Olympics.

Eric Liddell, a devout Christian, is the son of Scottish missionaries. Harold Abrahams is the son of a Jewish immigrant father. Each man runs with unique passion and purpose.

"Eric Liddell ... is traversing the landscapes of university as well as gaining notoriety as an athlete and a religious speaker," said Joe Perry, the actor who plays Eric Liddell in Rosebud's production, in an email interview. "There is a lot expected of this young man and Chariots of Fire is a story of how Eric chooses to follow his own moral path despite others' expectations."

Harold Abrahams is driven by his father's influence.

"He is driven to win," said Aaron Krogman, who plays Abrahams, in an email. Abrahams' older brothers are Olympians, and their entire family is driven to achieve, pushed by their immigrant Jewish father who suffered great antisemitism.

"Harold badly wants to win his father's love and interest, and also to get even with everyone for years of discrimination," he said. "Harold comes to believe that the only way to succeed is to beat Eric Liddell, but he is wrong. Over the course of generosity from Eric, from his romantic interest, Sybil, and from the care and investment of his coach. Sam, Harold learns to run for different reasons. Rather than running to make up for what has been missing in his life, he learns to run for and because of the good things already in his life."

Now, 100 years after Liddell and Abrahams ran against each other, their lives still speak to the actors who portray them.

"What I learn from Eric is that it is possible to hold strong to what you believe in a kind and gentle way," Perry said. "There is capacity to hold convictions and still have room for nuance, empathy and genuine care for all we encounter, and even to hold an equal respect and admiration for others and their convictions.

"A question that Eric asks of Harold and of himself is 'why do you run?" Per-

ry added. "This has inspired me to ask that question of myself about all aspects of my life. Finding and knowing why we do the things that we do, what and who we do them for can give such a drive and freedom to pursue goals with a focus and clarity that opens up the possibility for greater fulfillment.

"Eric's legacy is one that shows that we can meet adversity with grace and tenacity. That generosity of spirit and the spirit of competition are not mutually exclusive."

"I feel compassion for Harold," said Krogman. "He believes that if he can just win in a big enough way, then he'll be worthy of the love of his father ... that is such a sad thing for a kid to learn from their parent, that love is conditional, as long as the child performs. I love that Harold gets to let go of that curse over the course of the play.

"Harold thinks that Eric is his enemy, his target, his obstacle, but in fact Eric proves to be a true brother by inviting him into a much lighter, happier way of being. I wonder how often we wrongly classify the people in our lives."

"This year marks 100 years from the Olympics in which Eric won his gold and set the record in the 400m race,"

Perry noted. "The Olympics this year will be held in Paris once again. For me this play is a great reminder of the value of community, grace, understanding and conviction in a time of such turmoil and uncertainty."

Chariots of Fire opens in the Rosebud Theatre Opera House, April 5 and runs until May 25. Tickets include a buffet meal, though may also be purchased without. For more information and tickets, call 1-800-267-7553 or visit their website (rosebudtheatre.

I hope that everyone had a Happy Easter with family and friends!

Last week the Alberta Government announced changes to the Class 1 driver training and licencing by implementing a made-in-Alberta learning pathway for commercial drivers. This learning pathway was developed with input from the commercial driving industry and is designed to increase driver skills, improve safety, and enhance on-the-job training for current and prospective Class 1 drivers. This is a proactive approach to ensure commercial drivers in Alberta develop competency throughout their career. The apprenticeship-style model offers a learning pathway for Albertans to develop the skills to succeed and advance in their career as a professional driver, with the goal of seeking a Red Seal designation and the recognition as a professional trade. These changes will be implemented by March 1, 2025.

Additionally, Alberta's government is responding to the unique needs of Alberta farmers by exempting them and their immediate family from the requirement for pre-licence training and providing them a farm-restricted Class 1 driver's licence. This will allow farmers and their immediate families to operate Class 1 vehicles within Alberta only, and for authorized farm purposes only. Farmers who are eligible for the new farm restricted Class 1 driver's licence must still complete a knowledge test, road test, vision screening and submit a driver medical assessment. This new farm restricted Class 1 driver's licence will take effect on April 1, 2024.

Continuing with our updates, Alberta's government is fulfilling its promise to provide seniors with a 25 per cent discount on personal registry services to help keep life affordable, benefitting more than 725,000 Alberta seniors starting April 1, 2024. This will help provide some relief to seniors, many of whom are on a fixed income. When seniors visit their preferred registry office, they will be eligible for the discount on services including vehicle and driver-related services like vehicle registration renewals, driver's licences, standard licence plates, and vital statistics products like marriage licences. The date of purchase must be made April 1, 2024, or later, the senior must be 65 or older on the date of purchase, and no retroactive discounts will be offered. The discount is estimated to have a financial benefit to seniors of \$16.5 million to \$20 million annually.

These measures highlight our continuous effort to deliver meaningful results for Albertans.

The proposed transfer is an upstream transfer of allocation. The allocation of water to be transferred was licensed to Ferus Inc with a priority number 2004-03-12-001. The Commercial (cooling) purpose of the water use will be changed to Municipal (water supply).
