





# Mayor looks forward to 2025

With 2025 on the horizon, Strathmore Mayor Pat Fule looks back on the successes achieved through the year and what is soon to come for the town.

"I think we are pretty happy - there has been a (large) increase in development permits. We have had 186 residential permits issued, we have got some major development projects that are close to being ready, or else they have started construction," said Fule. "We have the Shasta seniors care community complex development on Park Lane Way, we have got construction started at the old seed cleaning plant ... it is a multiplex of apartment buildings, and we have had some really good construction and infrastructure

He explained the town is looking forward to issuing development and construction permits for more residential-type applications in 2025 and expanding Strathmore's capacity to house members of the com-

Between the 37 industrial, commercial, and institutional permits issued, \$27 million in building value was added to Strathmore.

Prior to releasing council until the start of the new year, the Town of Strathmore passed their new IDP framework bylaw which had been developed in partnership with Wheatland County, and was mandated by the province to be completed before the end of 2024.

"Another exciting thing for 2024, we were able to host for the second year in a row, Premier Danielle Smith during our Strathmore Stampede, and that kind of thing creates a buzz around the parade and the Strathmore Stampede," said Fule. "I think we are starting to be recognized as a destination for great events and for community things going on."

In May, the Town of Strathmore approved the Physician Sponsorship Grant pilot program, which aims to attract more physicians into town, making access to medical services easier and more reliable.

The program was initiated after hearing from local residents that doctor availability is tough in Strathmore. By offering grants to support local medical offices in town, Fule said the town hopes to help relieve some of the pressure on the local medical systems, as well as make community life a little bit easier.

Additionally, Frontier Diagnostics has expressed interest in and has put forward a proposal to bring a CT scanner into the Strathmore hospital.

# County passes first reading for multimillion dollar borrowing bylaw

Wheatland County council passed first reading for the Goldfinch Raw Water Debenture borrowing bylaw, 2024-07, during the Dec. 17 regular meeting of council.

The Goldfinch raw water line project received budget approval and successful tendering for \$9,750,000 during the Dec. 3 regular council meeting.

Once completed, the new infrastructure will service the Goldfinch Industrial Area, providing water services in order to facilitate both future industrial and commercial development in the area.

The borrowing bylaw, should it pass

third reading, will provide a substantial portion of the funding to construct the water line in 2025.

"Following approval, the advertising period will commence as required by the municipal government act. This borrowing bylaw and value falls well within the capacity of the county," said Joel Chiasson, manager of financial services with Wheatland County during the council meeting. "We reviewed during our budget process, the current debt limit calculated in the 2023 audit year was around \$52 million."

Repayment methods for the loan are specified to include revenue generation through levies and fees from users in order to help recover principle and interest costs.

Chief Administrative Officer Brian Henderson explained general taxation and debt repayments are a requirement of the Municipal Government Act (MGA) to be included in the county's budget on an annual basis.

He added the county will have to update their fee schedule after third reading of the bylaw is passed.

Following third reading of the bylaw, county administration will seek loan terms and conditions with the Government of Alberta, or another authorized financial body most advantageous for Wheatland County to negotiate with.

During the meeting, Coun. Glenn Koester inquired whether their intention was to hold a public hearing regarding the bylaw, given the amount of money intended to be borrowed for the construction of the water line.

"Administration was not intending to hold a public hearing on it, just as it is not required for this type of bylaw. The requirements for a borrowing bylaw would be to have first reading, then advertise for two consecutive weeks, which is why we are getting it done in December, so we can advertise over the closure in the break," said Henderson. "There is a 30-day window for a petition as well, so if administration does receive a petition on this borrowing bylaw, we would have to notify council regardless, so we are just going to follow the procedure that is outlined in the MGA."

Koester said the last time Wheatland County did a borrowing bylaw, it was in his division. The county at that time also did not hold a public hearing, and subsequently hosted a meeting in Rosebud in order to explain themselves.

"I said I would never, ever be party to another borrowing bylaw without a public hearing," he said.

In addition to first reading of the borrowing bylaw being passed, county administration was directed to schedule a public hearing prior to discussion on second and third readings.

## MP Martin Shields closes out 2024

As 2024 comes to a close, Bow River Riding MP Martin Shields reflects on the past year and looks to what 2025 may begin to look like.

Among his immediate concerns was the federal budget, seen by the House of Commons, Dec. 16 forecasting dramatic increases to federal debt.

"It was a little bit of a different year. Obviously, some legislation would be better than others, budget as the fall update, which we finally got ... at \$60 billion over and they had said \$40 billion is their guideline, which, \$40 billion is too much but it went over by 50 per cent," said Shields. "That is a lot of spending and so that is problematic. It took much longer to get that fall financial update out, but at least we got it ... that is problematic, that amount of deficit spending.

The federal government's deficit for the 2023-24 fiscal year, which concluded in March, was announced at \$61.9 billion as opposed to the \$40.1 which had originally been promised.

Currently projected is a deficit of \$48.3 billion in 2024-25, followed by a deficit of \$42.2 billion in 2025-26. These represent 1.6 per cent, and 1.3 per cent of GDP respectively.

"It is one thing to spend money on things that are good, that you can see the results of, but when we see that there is a lot of the money that is spent that just is not accounted for, or it is gone - disappeared under corrupt circumstances, that is problematic," said Shields. "Under the Indigenous set-aside fund at five per cent for Indigenous contracts, (I sit on) an Indigenous

committee where it is obvious that people have used shell companies to get government grants that were meant for Indigenous businesses, that are not Indigenous businesses ... and then there is no accountability for that money, or if it can't be tracked, no accountability for those who may be committing fraud."

Shields added the Conservative party is calling for an election, to which they are referring to as "a carbon tax

The premise being that carbon taxes would be reduced on Canadians, being different than the industrial carbon tax.

"We need to remove the carbon tax. Our largest trading partner, the US, does not have a carbon tax, so we are calling for that election," he said.

Regarding the Bow River Riding, Shields added he was pleased to see that the irrigation districts were able to access enough water for the season and not experience a shortage.

"Cattle prices continue to be very good, and so cattle producers are staying in the business mostly because the market has been very good in the sense of beef production," he said. "There is some movement on a sense of more drilling is happening, but the price of natural gas is still pretty low. There is continued work in some parts of the (oil and gas) industry we are seeing, for example, (in) helium. We have helium being developed in this particular riding."

Going into the new year, he added he would like to see the continued diversification of the agricultural industry in the region, suggesting more activity with growing sugar and potatoes, among others.

Bylaw 2024-07: Goldfinch Raw Water Line Borrowing Bylaw SECTION 258 - THE MUNICIPAL GOVERNMENT ACT

TAKE NOTICE that the Council of Wheatland County, in the Province of Alberta, has given first reading to Borrowing Bylaw 2024-07 which will, upon final passage and approval authorize the proper officers of Wheatland County to borrow \$7.75 million for a period not to exceed twenty (20) years, from the Province of Alberta or another authorized financial institution, by issuance of debentures and on the terms and conditions referred to in this bylaw, to construct a raw water line from wells diverting water from the Bow River to the Goldfinch Area Structure Plan (ASP). This project will improve water infrastructure and support future development in the Goldfinch area. Wheatland County shall repay the indebtedness according to the repayment structure in effect, namely semi-annual or annual payments of combined principal and interest installments not to exceed TWENTY (20) years calculated at a rate not exceeding the interest rate of 6.0%. There shall be levied and raised in each year of the debenture, hereby authorized, levies or fees towards users of the Goldfinch Raw Water Line to pay the principal and interest falling due each year. In the event of any deficiency, the Municipality shall levy and raise municipal taxes sufficient to



"The town has to pay for inflationary raises in things like gas, diesel fuel, automotive and mechanical parts, deliveries - everything goes up with inflation. It is really difficult and problematic for a town to go for a zero per cent."

With approximately eight months remaining of this council's term and the next election waiting in the wings, Fule commended council's efforts and achievements throughout their time serving together.

"This council has done some really good things. We have worked hard, we have worked well together," he said. "When we focus on the big-ticket items and when we focus on our strategic plan that we lay out ... we have done some really good things and we have managed to control and keep a good tax increase for next year.

"We have got some big projects done; we are looking to the future; we are going to be working hard to manage the growth in the early part of 2025. I am still excited by the job - I still feel a great deal of satisfaction when we accomplish good things as a group."

Fule specifically noted that on behalf of the town, administration and staff, he wished the local community a Merry Christmas, as well as a safe and happy

# **Looking forward to 2025**

As 2024 comes to an end, and we look forward to the opportunities of 2025, it's a time to reflect on the accomplishments and milestones of this last year.

Our government wrapped up a successful fall session - strengthening your rights, freedoms, and personal protections, making life more affordable, education more accessible, and empowering our healthcare sector.

To remain the province of the strong and free, we introduced and passed 13 crucial pieces of legislation, beginning with the Alberta Bill of Rights Amendment Act 2024. These amendments ensured that Albertans' rights and freedoms surrounding medical choices, property rights, and legal firearms use are protected in our fast-changing wor-

The Bill of Rights is further strengthened by The Health Statutes Amendment Act 2024, which protects the rights of Albertans during a public health emergency while adding further protections to preserve the rights of children and youth to grow and develop into mature adults so they can make informed decisions about their health and lives. The Fairness and Safety in Sports Act protects women's and girls' sports, ensuring meaningful participation in the athlete's choice of biological female-only and co-ed divisions.

We've heard from parents across the province that they want to be more involved in their children's education and we are happy to strengthen their involvement through the Education Amendment Act 2024, which focuses on promoting student success and well-being, and will ensure children, parents and teachers have the right supports to navigate complex conversations in Alberta's classrooms. We also passed the Early Learning and Child Care Amendment Act to increase oversight and provide more information to parents, while allowing for greater intervention and administration of penalties when providers fail to meet vital safety standards.

To conclude a strong session, we continued to stand up against the federal government's unconstitutional

overreach, passing an Alberta Sovereignty Within a United Canada Act motion to safeguard Alberta's economy from the job-killing federal emissions cap.

Keeping life affordable is a main priority for our government. This is why we are cutting up to 70 per cent of photo radar and lowering auto insurance rates. Effective April 1, 2025, automated traffic enforcement on numbered highways will end as photo radar will be restricted to schools, playgrounds, and construction zones. Our government is killing the photo radar cash cow, ensuring that radar is used for promoting safety and not revenue generation. Furthermore, we are working to significantly lower auto insurance rates while providing better benefits that Albertans can rely on if injured in a collision. Due to the time needed to create and develop the new system, these changes will come into effect in January 2027 and are expected to save Albertans \$400 a year once implemented.

To keep up with the incredible growth our province is experiencing, this year we committed \$8.6 billion to complete and open 200,000 new student spaces across Alberta over the next seven years through the School Construction Accelerator program. This program will build new schools in our fastest-growing communities, modernize aging school infrastructure in rural Alberta, and expand school choice by building new public charter schools. These new and modernized spaces will ensure that students have the resources to learn, grow, and reach their full potential.

We have made significant healthcare improvements over the past year to improve doctor, nurse, and healthcare worker recruitment. These improvements include an incoming new primary care compensation model for family medicine and rural generalist physicians and a new model for nurse practitioners to strengthen our primary care network. We are leaving no stone unturned to make sure Alberta's primary care system is the best in Canada.
