AHS launches an internal review

A Gleichen resident is launching a complaint with Strathmore Hospital regarding her mistreatment by two nurses and paramedics during her admittance. Tami Hutcheon said while she was in

need of medical services on and following Jan. 8, she was verbally abused by medical staff who were supposed to be tending to her needs.


"I don't know exactly what day it was or the time; friends of mine called paramedics because I started vomiting profusely and having explosive diarrhea. The paramedics came, they put me in the ambulance and the paramedics accused me of being on drugs," she said.

Upon reaching Strathmore Hospital, Hutcheon explained she requested a drug screening via catheter, hoping the results would be indisputable.

The results, though returning negative save for her prescribed medication, did not help to improve her treatment.

"The feces was all up to my neck, it was in my hair, down my legs, and they left me like that forever. The two nurses call me (vulgar names), they called me a drug addict," said Hutcheon. "They then transported me from Strathmore Hospital to Peter Lougheed Hospital and even the paramedic who transported me down there said 'the only reason she is being transported is because they didn't want to look after her."

Hutcheon added it wasn't until she returned from Peter Lougheed to Strathmore Hospital and was admitted to acute care, that her treatment and experience improved.

Those have got to be the nicest nurses that anybody could ever deal with," she said. "They were so kind to me, even they couldn't believe what had happened."



Town approves budget increase for snow removal, path maintenance tools

The Town of Strathmore is looking to improve its local road, sidewalk and pathway clearing services, as council approved the purchase of a new tractor for operational use.

Town Operations Manager Donna McCallum presented to Town Council, Jan. 18, to request the authorization of an increase to the budgeted amount, as this was not the original idea for serving the purposes.

When quotes came in for the municipal tractor, they were over the allotted budget amount. Also upon further review of the cold planer purchase, we discovered that the cold planer does not really operate as we had wanted it to," she said. "Basically, what it does is it grinds in a vertical motion as opposed to a horizontal motion which results in more of the original sidewalk material being removed."

McCallum explained the goal with the alternative snow blower attachment for the tractor would help to preserve the sidewalks and pathways much longer than if the cold planer continued its regular operations.

According to the report provided to council, operations staff have found it is more effective to grind the sidewalks and only removing as little of the original material as necessary.

For reference, a cold planer is a device used for

the controlled removal of pavement surface to a specific depth. The end result of cold planing is a restored surface free of cracks and tripping hazards, but is an aggressive process to use on sidewalks and pathways.

Additionally, the new tractor would be compatible with other equipment already maintained by the town, making it a versatile, multi-season tool.

"The snowblower and chute will allow operations to use the municipal tractor in the winter to assist with snow removal in case of a breakdown of our loader-mounted snowblower. It can also be used in smaller areas such as the alleys in case of a significant snow event," said McCallum. "This scope change would result in a small increase to the total budgeted amount. The new tractor will also be compatible with the attachments that we purchased previously, so it allows operations staff to utilize the attachments to conduct the additional tasks such as stump grinding."

Other uses for the tractor would include allowance for the distribution of ice melt, plowing pathways and sidewalks, mowing and sweeping.

The town had originally budgeted \$187,230 for the cold planer and the tractor, though with the requested scope change to account for the tractor, a snowblower attachment, and show chute, the new total would be \$189,228.

The change was approved unanimously by Town Council, following a motion put forward to authorize the change by Coun. Denise Peterson.

Quonset fire stopped quickly

The Strathmore Agricultural Society suffered damage on Jan. 19, when the Quonset building caught fire, damaging or destroying many of the materials inside.

"We got a call (Thursday) morning shortly after 11 a.m. that there was a structure fire out on our grounds. I ran out from the office with the rest of the staff there and noticed the fire department was already on scene and putting out a fire in our storage closet," said Ryan Schmidt, CEO of the Strathmore Ag Society. "I do want to really thank the Strathmore Fire Department for so quickly being on the scene. There were on that fire very fast and kept it under control, and the Wheatland County Fire Department also came out to help."

Inside the Quonset building, the Ag Society was storing roughly 100 bales of hay, as well as walls, materials and memorabilia for operating Halloween events on the grounds.

Schmidt added he was relieved that by the time he and his staff were notified of the fire, response crews were already on the scene working to conism and quickness of our fire department."

Ultimately, the damage is estimated to be around \$10,000 in value, which Schmidt said an insurance claim would be filed and investigated for. No staff or personnel were injured as a result of the incident.

There is no estimate yet regarding repair timeline, though he hopes to have the building ready to go by the start of the rodeo season in the spring.

According to Schmidt, the damage will not impact any events being hosted on the Ag Society grounds, as the building is mainly used for storage.

An investigation into how the fire started is being conducted by the Strathmore Fire Department. Both the Strathmore and Wheatland County divisions were involved in controlling the blaze.


"The cause of the fire is still under investigation, but we are working closely with the property's insurance investigators to determine the exact cause," said David Sturgeon, Chief of the Strathmore Fire Department. "This one will be a little bit harder because of the nature of the fuel. It was mainly hay bales on that side so it will be like finding a needle in a haystack. We will be sifting

BBB Tip: Flight canceled? Tips for handling travel delays BBB.



Consumers may have additional benefits if they purchased the flight with a credit card that offers additional travel protections. Check the cardholder agreement and with the airline. Consumers should keep receipts for extra purchases, like a hotel room, so they can submit them to their airline or credit card company for reimbursement later. Typically, nearly all domestic airlines will try to accommodate passengers on the next available flight, and sometimes on a different carrier.

When flights are canceled by the airline, consumers are always entitled to a full refund. This includes a of any bag fees or extras such as additional legroom for a seat. If the airli eu of a refund, ask about expiration and blackout dates. Airlines may also have additional restriction on the use of vouchers. Consumers are not obligated to accept vouchers and may insist on a full refund ead. If the trip was canceled by the consumer, however, they may not be entitled to a full refund

BBB is asking consumers to keep the following tips in mind when handling travel disruptions:

- Check delays Travelers can check their latest flight information on their carrier's website or via the airline's telephone reservation system. Many times, delays don't occur until the day of the flight and the airline must update its flight information within 30 minutes of receiving a notice of a status
- · Check carrier and credit card terms While federal regulations don't require airlines to reimburse expenses such as rooms or food in the event a flight is canceled or severely delayed, the carrier a credit card companies may have different policies. Purchase tickets with a credit card that offers otection or travelers insurance and check individual airline pol
- Keep documentation Keep receipts and records for expenses incurred as a result of a significantly
 delayed or canceled flight. These may be needed later to recover expenses.
- · Check the carrier's website Most airlines allow consumers to initiate refunds directly on the carrier's website. Using a website may help a consumer obtain a refund or rebook a trip much faster than waiting for a consumer service agent in person or on the phone
- Rules are different for foreign flights Flights that were canceled while in another country will be affected by the laws of that nation. Check with the local country's department of transportation while traveling internationally.

Gleichen woman launches complaint with Strathmore Hospital over mistreatment claims

Her grievances, she specified, were with the two nurses who attended her initially, as well as with the paramedics who transported her from Gleichen to Strathmore.

Hutcheon said she submitted a complaint with the hospital and spoke with an administrator, who she did not name. She added to have been informed an investigation into the incident would be launched "immediately."

"I want an apology from both of these nurses. I want them to tell me why they are apologizing to me, and I think they should take a course on why they shouldn't treat people like

that," she said. "You can't treat patients like that; they don't know what's wrong."

Hutcheon said she was diagnosed with pneumonia, an ear infection and a urinary tract infection.

Alberta Health Services (AHS) issued a statement in response to the claim on behalf of Strathmore Hospital.

"We are very sorry to hear that a patient is upset with their experience at an AHS facility. AHS has worked extremely hard across the organization, to develop a culture of compassion, accountability, respect, excellence, and safety.

"Strathmore Hospital site leadership has spoken with the patient to discuss the concerns. The patient was also informed that AHS has a Patient Relations service for patients and family members to work with if they have concerns about care."

AHS added an internal review is also underway regarding the complaint to determine details of the care provided to this patient. Results of this review will be available to the patient.

To protect patient privacy and confidentiality, AHS will not be providing further detail regarding this matter.

Strathmore Strikers U13 team headed to 2023 Slush Cup

The Strathmore Strikers U13 soccer team has opted out of attending their usual provincial tournament this year, instead heading off to a much larger stage.

According to Team Manager and Treasurer for the Strathmore Soccer Association (SSA) Stefanie Brown, the team is instead going to the Edmonton Minor Soccer Association (EMSA) Slush Cup.

"We decided to go to this tournament instead of provincials because of the size of the tournament. Just for reference, there are 14 teams in the kids division and they have never played at a tournament with more than six in their division," she said. "(The kids) are pretty excited to get to go and play on a bigger stage and see different teams that they have never played before."

The Slush Cup is taking place from March 2-5, which would have introduced a scheduling conflict with the Strikers' usual provincial tournament. Instead, the team will be setting out to compete against an entirely new set of opponents. Taking into account all competing divisions which will be in attendance at the Slush Cup, over 200 teams will be in Edmonton for the weekend. To date, the Strathmore Strikers U13 features players who have never been to a tournament before, including some players who did not begin playing soccer until this season.

To remedy this, Brown added the team will be competing in the Calgary Family Day Soccer Tournament in order to get the players acclimated to the tournament format.

"It is going to be very overwhelming for the majority of our players to go there and have 200 teams playing in a tournament," she said. "So for our players who have never played in a tournament before, we registered in the Calgary tournament, which is a lot smaller. There are four teams in our division."

The aim is to give them an idea of what competing in a tournament is like and allow them to experience tournament play.

The Family Day tournament is taking place through the Strathmore Strikers' home association, the Calgary Minor Soccer Association (CMSA) over the course of the Family Day weekend. In order to finance their trip to Edmonton for the Slush Cup, the Strikers are aiming to raise \$5,000 to cover many of their expenses, including those of their volunteer coaches - Erin Cunningham and Tristen Fraser. "The reason we are doing fundraising is mostly because we have two volunteer coaches, neither of them has a child on the team and they have committed to coming out to a tournament in Edmonton," said Brown. "To not have a child on the team and be willing to give up your own weekend time to come out there, we wanted to support them in coming out." The team is selling raffle tickets for an item that was donated to the team, they have a GoFundMe set up, and if local businesses are interested in supporting the team, they can provide a cheque to the SSA.

Local businesses to host Alzheimer's fundraiser

Strathmore's own local cornhole Local music retailer and instruction studio Max SPL music is partnering with Origin Brewery to host a fundraiser for Alzheimer's disease at the taproom.

Dan Wiewel, owner of Max SPL Music, said the idea came to him following the loss of a relative to Alzheimer's late last year.

"Unfortunately, my aunt passed away in December due to Alzheimer's and I was not able to attend the funeral, so I reached out to Origin to see if they wanted to put a fundraiser on," he said. "It's sort of my way of honouring her."

Finances raised at the event will be donated to the Alzheimer's Society of Calgary. Wiewel added the timing works out well, as January is Alzheimer's Awareness Month.

The event will consist of dinner, music, and a host of activities aimed at raising money and awareness for the charity.

"We have got music lined up supplied by myself and some of my fellow instructors here at the store, we have a silent auction going, they have got some great food going at Origin and ... Hunger Pains is donating 10 per cent of food sales to the charity as well," explained Wiewel.

A 50/50 draw will also be taking place at the taproom.

Wiewel added this is his first time being at the helm of organizing an event like this, however, partnering with Origin, he said, has made it a very smooth and easy experience.

"(Origin) has been amazing. I on a whim after everything happened in December, just sent them an email thinking I might be able to set something up there and they got back to me right away ... Competing against the best

Alie Chernoff of Strathmore will be demonstrating her riding abilities at the 2023 American Quarter Horse Youth World Cup in Bryan-College Station, Tex. from June 29 to July 8.

Every two years the event hosts 16 nations from around the world to compete for gold medals in various quarter horse competitions ranging from cutting, reining, horsemanship, ranch riding, trail, western riding, hunt seat equitation, hunter under saddle and showmanship.

Members, human and equine, are eager to be back in the saddle (pun intended) as this is the first live event since before the Covid pandemic began. 2018 was the last in-person event and a virtual event was held in 2020 where competitors from 13 counties participated.

Chernoff began competing when she was 13 years old. She got her start with competition when she was involved with 4-H and the passion continued to grow.

This will be Chernoff's last year that she is eligible for the youth category bringing mixed feelings for the rider as she will be aging up into the adult category.

"I'm excited to be ending this year with being able to go to the Youth Cup," said the 18-year-old.



Did you know your fingers are one of the worst sources of germs? Coughing or sneezing into your hands can transfer the germs and viruses to door handles, elevator buttons, light switches, gas pumps and toilet handles. "Alberta Blue Cross will never contact seniors - or any of our members asking for personal or financial information to provide a 'payment' to them, whether by text, email or phone," says Brian Geislinger, vice-president of Corporate Relations at Alberta Blue Cross. "Anyone who receives a suspicious request and has concerns should contact our Customer Services."

Alberta Blue Cross recently worked with the Alberta Injury Prevention Centre to publish a booklet for older adults, called "Keeping Well," that includes two pages of practical tips to help Alberta seniors avoid becoming the victim of fraud.

Fraud is the number one crime against older Canadians. Criminals often target seniors as they may have more money, can be more trusting and are home during the day to answer the door or phone. Online, email and text scams have become increasingly common. Common types of scams include free items or vouchers; fake competitions; free money from the government; tax rebates and refunds; and pension and investment scams.

Tips to help older Albertans protect themselves from fraud and scams in-

· Never give out money or personal information to someone over the phone, at the door or in an email unless you can confirm the identity of the person or organization you are speaking to.

• Don't respond to emails that look suspicious, or open any links or attachments associated with them. Emails can be made to look like they came from a person or organization you know.

 Don't click on pop-up windows – you can safely close the window.

· Don't sign agreements or contracts without giving yourself time to think it over - this includes limitedtime offers.


 Request proof of identity or check references before hiring someone or agreeing to have them work on your home.

Victims of fraud may feel embarrassed, think the amount of money they lost is too small to worry about or worry they might not get their money back. Regardless of the situation, individuals who think they've been scammed should always report it to local authorities. Not only can law enforcement help these individuals but reporting fraud can also stop someone else from being scammed.

Crowther Memorial classes going green

Crowther Memorial Jr High School teacher Lindsay Walker is encouraging her language arts students to go green, challenging them to create ideas through a class project.

The idea came after her Grade 8's watched Pixar's Wall-E and completed a film study on the movie.

"Part of that movie is humans have destroyed the earth ... and so I wanted to challenge my students (to think about) what we can do to try to make this not happen to our earth," she said. "They could choose anything they wanted and they were working in groups of four and (thinking about) what they could do to address this issue."

Walker explained the topic is something she is passionate about and figured it would be an excellent opportunity for her students to feel empowered that they can influence positive change.

The students worked on creating projects entirely of their choosing. Some opted to raise awareness about compost and rain barrels, some chose to raise money for charity, and others chose to look at aquaponics at the school. Some students also approached the project looking at different ways to incorporate gardens that benefit pollinators into the school. take on a project of this nature.

"I hope that they learned ... that they can do important things and hard things. Even though they might feel like they don't know enough or are scared to, they can work together to reach a goal," she said. "We do have some composting that happens and groups after lunch take care of that. Our hope is to increase the composting going on in our school."

Students also have the option to join an agriculture club at the school, or for those in leadership classes, they have some freedom to take on projects largely of their own passions.
