# Town eyes new app

A presentation given before Town of Strathmore council during the Jan. 22 regular meeting detailed the launch of local Geographic Information Systems (GIS) and Economic Development Dashboards.

The development of the Public Web Map and Economic Development dash-boards aims to provide residents and businesses with easier access to information, while supporting the town's economic development goals.

"This tool will provide our residents, businesses, and other stakeholders with easy access to property information, reducing the need for direct inquiries and empowering a self-service for our community," said Seth Whitney, GIS specialist for the Town of Strathmore. "The public property search web map is an app that is user friendly, and a web-based map where users can search properties by various criteria like address, tax roll number, or even by zooming into the map."

Whitney explained the map provides a convenient and intuitive way to gather information on properties, including details on assessments, taxes, and zoning.

This also includes information such as lot size and garbage pickup days for a given property. All of this is to be made available online with constant accessibility, without the need to contact town staff.

"The tool brings multiple benefits: first, it reduces the number of calls and inquiries that staff need to respond to by allowing residents and businesses to get to the information themselves," said Whitney. "Second, it provides faster access to property details, meeting the growing demand for transparency and convenience. It is especially useful for real estate agents, assessors, and resident who need quick access to this type of information."

Sensitive information regarding properties, such as property owner identities and contact information has been removed from the app.

# Strathmore Legion recognizes, awards students

The Strathmore Legion hosted an awards ceremony, Jan. 25, for students who participated in their annual youth remembrance program.

Students who were to be awarded for their entries were invited to the ceremony at the Legion building. Any student who placed first in their respective entry category will have their work continue forward to a similar competition, which evaluates entries from across the province.

"All the students in various schools in the Wheatland County area participated this year. We have some as far as Langdon and Wintering Hills - they all participated in the poster and literary contest," said Anna Haines, poppy chair for the Strathmore Legion. "If a student moves forward, they have the potential to go up to the national level. If they win at the national level, their posters and essays will be at Parliament Hill during the Week of Remembrance."

The youth remembrance program typically begins in October, when contest information is distributed to local schools within the region.

Subsequent deadlines for students to submit their work typically fall in early

December, prior to students being dismissed for their winter breaks. Evaluations at the local, then provincial levels take place in January and February.

Participation incentives include monetary prizes for students who are awarded first, second, and third place. Entries, divided into posters, essays, and poems at each respective age category, are judged at the Legion by veterans and members.

Subject matter of entries from student submissions is to depict their understanding of remembrance, and what it means to them.

Haines explained each year, the number of students who choose to participate in the program continues to steadily grow.

"Three or four years ago, we had a teacher participate from Wintering Hills Colony, which was a new thing for us, and this year we had a teacher reach out to us from Langdon ... and they have been participating," she said. "We are very pleased to see that they are putting remembrance in part of their curriculum in the fall, and it is not just about having a Remembrance Day ceremony, it is thinking about it beforehand."

A total of 25 students ranging from Grades 1-12 were recognized this year during the ceremony, and were presented with their prizes.

From among these, 10 first prize winners are being forwarded on for Alberta/Northwest Territories Provincial Command judging.

Haines added at least two winners from the Wheatland County region have on previous occasions proceeded to be recognized at the national level of the program.



## Water Reservoir Borrowing Bylaw discussed

Town of Strathmore council passed first reading for Bylaw 25-03, being the Water Reservoir Borrowing Bylaw, during the Jan. 22 regular meeting.

Riley Brolly, manager of financial planning, budgeting and reporting with the Town of Strathmore, explained the Water Reservoir Borrowing bylaw is an administrative requirement to ensure the town's compliance with the Municipal Government Act.

"When council approved the 2025-2034 Capital Budget on Dec. 4, 2024, the largest capital project was the Wildflower Water Reservoir upgrade in the amount of \$5.45 million over two years - most of it this year, and \$150,000 in 2026 which was approved to be financed by debt sources," he said. "We recommended this and council approved it because these upgrades exceed what is available to draw from reserves or to fund with incoming or expected grants."

Brolly added borrowing funds for this project will allow both current and future taxpayers to contribute to the cost of the water reservoir upgrades.

Bylaw 25-3 authorizes town administration to obtain a loan at no higher than 5.5 per cent annually on a 25-year term.

The interest rate on a 25-year loan from the Province of Alberta is 5.28 per cent, which represents an annual debt servicing cost to the town of \$395,000 annually on the loan, of which the funds to repay the loan must be levied on local taxpayers.

"The capital expenditure itself and the debt servicing on it is (already) factored into the (2025) budget," Brolly clarified.

The Town of Strathmore plans to decommissi-

on the Brentwood Reservoir, as well as to expand and complete the Wildflower Reservoir in order to allow it sufficient capacity to operate as the sole drinking water reservoir for the Town of Strath-

Renovating the Wildflower Reservoir, as well as decommissioning the Brentwood Reservoir have been subjects of the town's attention for several years, as the latter nears the end of its service life.

The Wildflower Reservoir was noted in October 2024 to be operating at its maximum capacity, while the Brentwood Reservoir was noted to operate at approximately 50 per cent capacity.

An Alberta Municipal Water and Wastewater Partnership grant is a resource which the town has previously applied for on multiple occasions. No mention of a successful application was noted on council's meeting agenda, nor was it discussed during the Jan. 22 meeting.

"I am very excited about this – I know that water is a scarce resource. Obviously, this is the thing that we most need to be focusing our attentions on," said Coun. Brent Wiley.


Council has directed administration to advertise the drafted bylaw in accordance with policies in the Municipal Government Act prior to second

Any questions or concerns regarding the bylaw must be returned before council within 30 days of second and third reading, which are to take place in February.

Following approval of the bylaw, the town anticipates to receive funds approximately by Sep-

### Strathmore RCMP reflect on 2024

Strathmore RCMP Staff Sgt. Mark Wielgosz reflected on 2024 and reported significant drops to criminal code offences over the course of the calendar year.

"As far as 2024 is concerned, generally across the board, we look at our municipal crime stats, being in the Town of Strathmore and our rural crime stats ... we saw our greatest reductions in, across the board essentially, for the Town of Strathmore last year," he said. "Versus the year prior, we have had an overall 24 per cent decrease in criminal code offences. I can attribute much of that progress to the hard work of our members who are out there every day working on our crime reduction and prevention initiatives."

These include targeted activities such as the habitual offender management program, as well as the home safety initiatives within the Town of Strathmore.

Wielgosz added the Strathmore RCMP observed five-year lows with crime numbers across the board from property crimes to persons crimes.

In local rural areas patrolled by Strathmore RCMP, some increases in offences were observed, though no more than five per cent compared to the previous year.

"Most of that is occurring generally within the close proximity around Calgary, and they will be targeting vehicles for auto theft and business break and enters along some of our industrial areas in those zones," said Wielgosz. "We are obviously going to be paying attention to 2025 to make sure that we are tackling those challenges and dealing with them as best we can to see those rates coincide more with what we are looking at targeting in our five- and six-year crime averages."

A significant component of ongoing prevention, detection and deterrence activities is in public

education. Messaging with respect to preventing crimes of opportunity is being distributed throughout the local region in an effort to reduce auto theft, theft from motor vehicles, and other property crimes.

Among the programs rolled out by the detachment in 2024 was Operation Cold Start, which will be operating again through 2025. This involved RCMP members patrolling the community and checking unattended vehicles which had been left running to ensure they were locked.

In instances where a running vehicle was left unlocked, members would make inquiries to identify the owner and initiate a conversation to ensure the vehicle was safeguarded.

"I think overall with some of our crime prevention initiatives – our habitual crime management program in particular, I really do think we have set a bit of a reputation, or perhaps at least some knowledge that Strathmore is well protected and perhaps that other locations are probably more viable for persons who are looking to commit crime," said Wielgosz.

He added the Strathmore detachment aims to continue its priorities which it has executed over the last three years since his arrival. This includes the continued reduction of theft of, and from motor vehicles, as well as increased road safety.

"We still treat all levels of crime in the community importantly, and just because we have certain areas of crime that we have listed as our priorities does not mean that we do not equally investigate others" he said

Wielgosz added if there is feedback from the public regarding where they would like to see their police service in the community focusing their time with respect to specific offences, they are encouraged to be in touch with the detachment, as well as to attend community engagement sessions planned to take place throughout the year.

Upon receiving support from council, public communication regarding the app will be distributed in order to increase awareness, as well as to teach people how to utilize the app effectively.

Whitney also clarified to council, town or RCMP staff, for example, would only be able to discover property owners' names through the app should their job require such information to be dis-

Only at such a time would permissions be granted to view that information. GIS aims to remain Freedom of Information and Protection of Privacy (FOIP) compliant regarding disclosure of potentially sensitive information.

GIS has indicated they have a target launch date of March 17. More information regarding the project is available via the town's Jan. 22 meeting agenda, as well as on their YouTube channel.

### Town passes 2025 Operating **Expenditures Line of Credit Borrowing Bylaw**

Town of Strathmore council passed all three readings for Bylaw 25-01, being the 2025 Operating Expenditures Line of Credit Borrowing Bylaw, during the Jan. 22 regular meeting.

This bylaw was recommended by town administration to be passed as a contingency approach to support the town's existing line of credit. The action required the passing of a bylaw in order to be in compliance with the Municipal Government Act.

The requirement of authorizing a municipality to borrow via a bylaw is listed under Section 251(1) of the Municipal Government Act. This section also applies to operating expenditures for a municipality.

The line of credit would serve to aid in the provision of services to residents, businesses and stakeholders while taxes are being collected until July 1.

Following tax collections, any use of the line of credit would be repaid immediately. Despite the recommendation for approval as a contingency, administration does not anticipate any use of the line of credit will be necessary.

"The town has had an operating line of credit of \$770,000 for a number of years. As far as I am aware, we have never had to dip into the line, but it is a contingent response tool in the event that we need to use it," said Riley Brolly, manager of financial planning, budgeting and reporting with the Town of Strathmore.

"We bring it to (council) right at the start of the year to get this in place in case we need it in an emergency ... it lets us respond a little quicker if (or) when needed."

The financial report provided to council indicated the town has not drawn on its line of credit in more than five years. Additionally, there is no financial impact to the town until such time that the line of credit is required to be drawn upon.

Passing a bylaw authorizing the use of borrowings is an annual occurrence for municipalities which have a line of credit available to them.

Following its approval, town administration is then tasked to arrange for the bylaw to be signed and provided to the Bank of Nova Scotia with the 2025 Line of Credit Bylaw.

Despite being a new bylaw, Section 256(3) of the Municipal Government Act states the bylaw is not required to be advertised if the borrowing term does not exceed three years.

Coun. Brent Wiley motioned for council to approve all three readings for the Operating Expenditures Line of Credit Borrowing Bylaw. Each in turn was carried unanimously without deba-



Ernie is survived by his wife of 68 years Elizabeth (Betty); two daughters, Sandra (Ken) and Sharon (Paul); five grand-

children; brother Vern (Flo) and nieces, nephews and cousins. He was predeceased by his sisters Ann and Kelly.

Ernie was born in Preeceville, SK in 1933, and moved from the farm with his parents to Saskatoon in 1942.

TAKE NOTICE that the Council of the Town of Strathmore, in the Province of Alberta, has given first reading to borrowing By-law No. 25-03 which will, upon final passage and approval, authorize the proper officers of the said Town to borrow monies from a Canadian Chartered Bank or the Government of Alberta on the general credit and security of the municipality, to pay for upgrades to the Wildflower Reservoir located in Strathmore, Alberta.
