Town of Strathmore council has approved the transfer of \$200,000 from the financial stabilization reserve to fund operating costs incurred related to the June 2024 Calgary water main break.

The approved transfer is on the understanding that town administration will be exploring the possibility of cost recovery of eligible expenses through the Province of Alberta's disaster recovery program, or other forms of claim reimbursement.

Town council discussed the matter during the June 19 regular meeting in council chambers, with the motion to approve made by Coun. Brent Wiley being unanimously approved.

It was explained to council the money, upon approval of the transfer, is not immediately utilized, but is approved to be available if, or when, it may be required to respond to a given need in relation to the water main break.

The approval of the budget transfer was explained to council during the meeting that clear direction is ensured from council to administration on the permissiveness of the expenditures and their funding source.

Prior to the reserve transfer approval, the town maintained a balance of \$1.84 million available, as of June 18. Should the \$200,000 be spent, the residual reserve balance will be \$984,000. Any funds recovered following the expense, or not spent at all will fall back into the reserve by a future council motion.

The town has also planned for the unlikely contingency of requiring water to be trucked in from outside the local region. This plan would consist of 30 triaxle trucks doing four water dumps per day in order to satisfy the water needs of Strathmore's population. Cost estimates of this contingency suggest potential expenditures of \$120,000 per day.

This estimate also covers overtime costs for staff who would be involved in this type of emergency response, although exact numbers of such an expense, should it be required are unknown.

# Town passes update to regional emergency management bylaw

The Town of Strathmore passed the Regional Emergency Management Bylaw, No. 24-09, during the June 19 regular meeting.

It was recommended to council by administration that all three readings of the bylaw be held during the meeting.

"During the last committee of the whole meeting, Apr. 10, council reviewed the bylaw and suggested changes. At that time, there were no significant changes," said Dave Sturgeon, Strathmore fire chief. "During our annual review of the bylaw, an emergency plans staff from the Alberta Emergency Management Agency (AEMA) suggested changes to the regional emergency management bylaw 22-05. The proposed changes outline the regional partnership procedures, the agency, the committee and the roles and responsibilities tied to each, ensuring greater clarity for all partners."

Some of the proposed changes in the bylaw presented to council included the removal of the planning coordination group, the addition of the City of Chestermere, authority and responsibility of both the emergency management committee, and of the regional emergency management agency.

Sturgeon added the proposed changes to the bylaw align with the local authority emergency management regulations, and the provincial emergency management act.

Proposed changes to the Regional Emergency Management Bylaw were first brought before town council during the April 10 committee of the whole meeting, which were then passed to administration to finalize the proposed

bylaw prior to returning to council.

The Regional Advisory Committee met on April 25 to review proposed changes to the bylaw. At the time, the committee did not provide feedback with concerns and were in support of the bylaw returning before Strathmore town council for approval.

A Regional Emergency Management Program was established in 2019 for Wheatland County, the Villages of Hussar, Rockyford and Standard, and the Town of Strathmore, funded by the Province of Alberta.

In 2022, the Town of Strathmore approved the Regional Emergency Management Agreement. Come 2023, this agreement was updated to include the City of Chestermere, which improved



It is important to protect your eyes from sunlight during these long days of summer. Water in the ear after swimming after is another summer problem. To solve, you can tap your head to one side to help the water drain gently while pulling on the earlobe. Try using a blow dryer on its lowest setting and blowing toward the ear. You can also try a mixture of 1:1 white vinegar and rubbing alcohol. Instill a few of these "drying drops", tilt the head and let them drain out.

the capacity of the agreement to respond to large-scale emergencies and disasters.

In order for the bylaw to have been able to receive all three readings during one council meeting, it was required that permission be unanimously given by council to hold third and final reading, following the first two.

Coun. Denise Peterson motioned to

give first reading, followed by Coun. Melissa Langmaid to hold the second, Richard Wegener to give unanimous consent to third, then back to Langmaid who motioned for third and final reading.



#### **Outdoor Water Restrictions | FAQ**

On the evening of Wednesday, June 5, 2024, an extensive water main break occurred in the community of Bowness in Calgary. This was a significant break on a critical water main that moves water across the city. On the morning of June 15, 2024, Calgary declared a state of local emergency (SOLE).

#### What is a SOLE?

Section 21(1) of the *Provincial Emergency Management* Act empowers municipalities to declare a state of local emergency. Declaring a SOLE provides municipalities with additional tools within their municipal boundaries that are normally unavailable or limited under the *Municipal Government Act* (MGA) and enables more coordination of action.

Calgary has declared a State of Local Emergency (SOLE) due to the repair timeline being extended by three to five weeks after finding an additional five areas in need of repair, further constraining water supply. The SOLE will give the City of Calgary additional powers, such as the ability to enter private property, remove trees, and activate emergency plans and programs.

Please note, Strathmore is NOT in a SOLE at this time.

#### Why are there water restrictions in Strathmore?

Calgary has notified their neighbouring communities, including Strathmore, of a water main break affecting water supply. They've implemented Stage 4 outdoor water restrictions and since Strathmore's water supply comes from Calgary, the Town is doing the same.

## Why don't we have our own water treatment plant in Strathmore?

Municipal wastewater and stormwater management is regulated by the Province, which takes a comprehensive approach to municipal wastewater management. There are many benefits to the Town receiving water from Calgary through the East Calgary Regional Waterline (ECRWL). These benefits include: security of supply for potable water, consistency of quality, reduced capital and operating cost for the water supply treatment, and the alignment with water conservation programs and targets.

#### What does Stage 4 outdoor water restrictions mean?

Residents are asked to immediately stop outdoor water usage. All outdoor water use is temporarily banned, and indoor water conservation is strongly encouraged. **How long will the restrictions be in place?** The duration of these restrictions is not yet known. More information will be provided as soon as we receive it.

#### Is indoor water use restricted?

To help do our part, we encourage all residents to voluntarily decrease indoor water usage.

## Why must I continue to pay a water distribution fee if water access is limited?

While water access may be limited at this time, it's important to note that residents and businesses continue to have access to water. We encourage indoor conservation efforts, but they are voluntary at this stage. Distribution fees are necessary for pipeline maintenance, an activity currently underway in Calgary. meet health code standards, such as health centres and restaurants.

## Why can the Town continue watering plants and flowers when I can't?

The Town uses rain and/or non-potable water for watering the public's plants and flowers. These water sources do not draw from the potable water we access from Calgary.

#### Why can't I have stormwater to use?

There are numerous reasons why the Town can't offer stormwater to residents. The water in our storm ponds is contaminated by runoff from the Town's roads, paths, etc. For this reason, liability and safety concerns must be addressed before the Town can consider offering water from the Town's storm ponds to residents.

#### Why can't I access water from the canals?

Water in canals is owned and distributed by the Western Irrigation District (WID) through water licensing agreements. With the potential drought and existing water license agreements, 90% of water owned by WID is allocated to irrigation usage.

## What's the difference between potable and non-potable water?

• Potable Water refers to water that is safe for human consumption (drinking, bathing, etc.).

• Non-potable Water refers to water that is not safe for human consumption but may be used for irrigation and other non-drinking purposes. This water is NOT safe for human consumption because of bacteria, viruses, and other contaminates that could adversely affect your health.

Other terms that you may hear during the next few weeks include:

• Clean Water refers to treated and purified water suitable for human consumption.

Grey Water refers to water already used domestically, commercially, and industrially (that is not contaminated with toxic chemicals). Examples include leftover, untreated water from washing machines, bathtubs, and sinks. This water may provide important nutrients for your plants.
Black Water refers to contaminated with toxic chemicals that should not be consumed or reused.

#### Is there a fire ban?

There is currently no fire ban. Strathmore's fire suppression capabilities remain unaffected. However, the Town Fire Department has provisions in place for the use of nonpotable water, in the event that the fire hydrants become unusable.

#### Are any Town facilities affected?

To support outdoor water restrictions and voluntary indoor water restrictions, the Strathmore Aquatic Centre is closed until further notice. The Strathmore Motor Products Sports Centre and the Strathmore Family Centre Arena will maintain regular operating hours, but showers are closed.

Why are some of the high-water usage businesses still open (e.g., the garden centre and car washes)? Stage four water restrictions apply to outdoor watering only; there are no commercial restrictions. However, all residents and businesses have been asked to reduce water use where possible. We are proud to share that many of our local businesses have voluntarily made decisions that have dramatically reduced the amount of water being utilized. Additionally, in the case of car washes, these operations primarily use recycled (non-potable) water.

#### Land Use Ammendment

## **Upcoming Public Hearing**

**Purpose:** to permit Garden and Garage Suites as a discretionary use.

#### **Bylaw #24-14**

Staff have created a comprehensive Land Use Bylaw amendment addressing Garden and Garage Suites. These regulations propose adding Garden and Garage Suites as a Discretionary Use to several of our lower density residential land use districts, making it possible for some residents to apply for a Development Permit for a Garden or Garage Suite on their property. There are a number of regulations proposed, including minimum lot area, minimum site width, maximum height, parking regulations, servicing of the proposed suite, and more. The regulations are based on an analysis of citizens' needs and inquiries, as well as a comparison of existing regulations across Alberta and Canada.

#### **Public Hearing Process:**

A copy of the proposed Bylaws may be inspected by the public during regular office hours, 8:30 am to 4:30 pm, Monday to Friday at the Town Office (1 Parklane Drive, Strathmore, AB), or can be found on the Town website (https://strathmore.ca/en/townhall/public-hearings.aspx). Please contact the Town Office if you would like an opportunity to review and provide input on the proposed amendments prior to the Public Hearing.

The Public Hearing will be held via ZOOM **AND** in Council Chambers, Strathmore Municipal Building, 1 Parklane Drive, Strathmore Alberta on **Wednesday**, **July 3rd, 2024**, commencing at 6:00pm with procedures in accordance with the *Municipal Government Act*, Section 199 and the Town of Strathmore Council Procedural Bylaw #23-17 and amendments thereto. Any person or group of persons, or person acting on someone's behalf, who claims to be affected by any of the proposed bylaw may present suggestions or concerns by making a submission to the public hearing. Please contact Please contact Legislative Services at Isadmin@ strathmore.ca by 12:00 noon on **Wednesday, June 26th, 2024**, in order to register to present.

Written submissions to the Public Hearing or the name of any person wishing to make an oral presentation at the Public Hearing must be received by the Planning and Development Department prior to 12:00 noon on Wednesday, **June 26th**, **2024** as outlined in Bylaw #23-17 and amendments thereto. If your written submission is not received by this time, please provide fifteen (15) copies for distribution at the Public Hearing. Each person wishing to address Council at the Public Hearing shall complete their verbal presentation within three minutes.

Please note that written submissions will become public documents once submitted to the Town, unless otherwise requested.

#### Is there a boiling water advisory?

There are no boil water advisories in effect within the Town of Strathmore and water remains safe to drink.

#### How can I help?

Here are some examples of ways you can pitch-in through indoor water conservation:

- Use dishwasher(s) and washing machine(s) only when required and with full loads.
- Turn off the tap when brushing teeth or shaving.
- Limit showers to five minutes or less and keeping baths shallow.
- Scrape plates clean rather than rinsing food off.
- Turn off humidifiers and ice machines.

• Businesses using large volumes of non-essential water, such as laundromats and car washes, are being asked to reduce water use.

• Businesses using water to deliver a product or service that is life sustaining for people and animals are exempt. Other exemptions include any businesses that must use water to

#### I see people watering, what do I do?

Some people might be using non-potable water from a rain barrel or holding tank. Others might have WID water rights or a well. Talk to them, they may not be aware of the restrictions. If you have questions about this or wish to express a concern, contact Municipal Enforcement who always strive to take an education-first approach.

## Limiting distractions in schools

Alberta's government is committed to ensuring that our province remains the best place to live, work, raise a family, and start a business. That is why, we are investing in the next generation through a new limiting distractions policy to help Albertan students succeed as they pursue their education.

After receiving feedback from more than 68,000 parents, teachers, education partners, and students, an overwhelming consensus showcased how personal mobile devices and social media can negatively impact students' learning, achievement, and performance.

In addition, countless studies have also showcased that social media can fuel mental health issues, such as anxiety and depression, which are growing in prevalence among youth. 





## Town approves CIP funding

The Town of Strathmore approved Community Improvement Program (CIP) funding for four different organizations throughout the local community during the June 19 regular meeting.

Through this, Project HOPE was approved for \$3,000, the Strathmore Musical Arts Society for \$5,000, the Vault Cultural Collective Society for \$1,500, and \$1,950 for the Wheatland Whirlers.

The CIP provides grant funding to Strathmore and area-based not-for-profit community organizations in an effort to support the myriad of recreation, culture, and social-based programs and activities which can be found around the town and local region.

The idea is that these programs and activities help to enhance Strathmore's overall identity, sense of place and quality of life for its residents.

Following council's approval of the funds, there remains approximately \$8,550 in the CIP fund, with two remaining intake periods for applications which may result in funding being allocated from the 2024 budget.

Had council not approved the funding allocations, the applications would have been returned to the CIP evaluation committee for further review.

The CIP Evaluation Committee met May 8, to review the four applications, scoring each of them and determined whether to bring the applications before council based on the scores each application received.

Project HOPE presented an application for \$6,062.45 for funding associated with the rental costs necessary to host the 2024 celebration gala at the Strathmore Civic Centre. The application requested funds to cover the rental fees at the facility.

The committee recommended the application for approval by the Town of Strathmore, but in the amount of \$3,000 to partially cover the costs associated with the facility rental.

Strathmore's Musical Arts Society made a request for funding associated with the shortfall incurred by hosting musical arts events. The request presented was for \$5,000 to cover the budget shortfall for an event.

It was recommended by the committee that the application be approved, though a letter also be sent to the organization regarding funding, as per local bylaws.

The Vault Cultural Collective Society submitted their application for funding regarding the "Exploring the Artist in You" pilot program, being a fine arts camp for students. The application was for \$2,000 to cover expenses.

Approval was recommended by the committee for \$1,500 to partially cover the expenses outlined in The Vault's application.

Funding requested by the Wheatland Whirlers was to help cover expenses associated with hosting Square Dancing in the Park. The \$1,950 outlined in their application was for the cost of the caller and queuer.

The committee recommended that council approve the application in full, though to also send a letter to the Wheatland Whirlers about the funding, as per local bylaws.


## Bark in the Park returns for sixth year

Strathmore's annual Bark in the Park returned for its sixth annual iteration, continuing its trend of growth, seeing more people and their dogs coming out to participate.

The event, as it has been previously, was hosted by Debbie Mitzner, who was as excited as ever to bring Bark in the Park back for another year.



"This is year six, it gets bigger and better every year; we had lots of vendors, it was a free event, lots of different dogs this year we had a food truck, we had a play area for dogs to have a run in, (and) people got some free giveaways," she said. "We felt really good about the turnout - there was no wind, no rain, it was a really good day for people to be out here with their families and dogs."

Mitzner explained the event started out much smaller than what it is today. As some people in the community are dog owners and do not have children, this is their family event of the vear

As Bark in the Park has grown, the event has expanded to include a market consisting of local vendors; rescue dogs are present and up for adoption, and food trucks have begun to stop by.

The sixth annual Bark in the Mitzner estimated the event is approximately four times larger now than when it debuted six years ago.

"There are no fees or tickets at all, we just want to give back to the community ... we had a lady come by to clip nails, we usually have one of the vet clinics here for advice, but they were unable to attend (the event)," she said. "We re-book the people this year for the next date next year, and anyone is welcome to hook onto our event and start enjoying this."


The inspiration for Bark in the Park originally stemmed from a similar event which took place in Calgary that had inspired Mitzner.







## Lakewood of Strathmore donates \$46,000 to #NotInMyCity

Lakewood of Strathmore celebrated the conclusion of their campaign alongside #NotInMyCity, which began last year, with an event taking place, June 22 in Brave Park.

The campaign saw the commitment of \$1,000 donated from every property in Phase 2 of the Lakewood development sold the charity.

#NotInMyCity is an organization dedicated to raising awareness and taking actions to prevent and end human trafficking and sexual exploitation.

This project concluded with the donation of \$46,000, which represented every single lot which had been outstanding to sell at the start of the initiative.

"I think one thing that is always overlooked is that community builds community, and if money, resources and energy were not put back into social programs and different groups such as #NotInMyCity, organizations like True North here in town, our community would not be what it is and it would not be what we hope it to be in the future," said Scott Silva, director of sales and marketing for Lakewood of Strathmore. "This was really just part of reinvesting back into the community and those organizations that helped make us who we are today."

Silva added Lakewood of Strathmore maintains a close relationship with Paul Brandt, who spearheads #NotInMyCity, due to having worked with them for the past approximately 18 months.

A goal of Lakewood of Strathmore's was to operate a campaign with #NotInMyCity, serving to gather a lot of attention to the community, such that

similar campaigns could be launched with other community organizations in the future.

"With every phase, we want to commit that phase to another donation. This phase was for #NotInMyCity. The next phase, which will be bringing on lots in about 90 days, we are going to announce who we will be committing that phase to as well," said Silva. "We have got about 450 homes left until we are done, because the entire community will be about 550 homes, so every phase we are going to be dedicating funds back to a local organization or a regional organization that has an impact in making differences in lives every day."

Silva also ascribed the sale of all of Phase 2 lots to the hard work and dedication of the development team at Lakewood of Strathmore. #NotInMyCity and Lakewood of Strathmore will be continuing to collaborate through events and projects throughout the year, which have yet to be announced.



## Wheatland **Conservation** & Wildlife Association hosts annual fishing derby

The Wheatland Conservation & Wildlife Association hosted their annual fishing derby, June 22, encouraging local kids to come out and learn to fish.

Mike Adamschek, fishing chairman of the The Wheatland Conservation & Wildlife Association, explained the event is aimed at kids 15 and under, as well as for seniors 65 and older, who do not require fishing licenses to participate.

"What we do here is an annual fishing derby, which we encourage to get the kids out and participate and get into fishing," said Adamschek. "We are a nonprofit but we help out - we give them fishing rods, we collect prizes from around town, there are some local sponsors who help us out generously ... overall we just want to encourage people to get out in the outdoors and into the fishing game."

Though an exact number of years was unknown, Adamschek said the association has been running annual fishing derbies for at least 20 years, with the organization having formed in 1996.

Response from the public, he added, tends to be extremely positive on an annual basis, with dozens of families coming out to participate.

"We have a lot of returnees here who said they were in this derby about three years ago, and they are coming out now every year. They love it, it gets families out ... there are a lot of people out here and it is a fun time for the family," said Adamschek. "The kids are loving it, it gets the families out. If you look around, they are all having fun and not sitting at home on the couch and playing video games. That is what we encourage, to get everybody out."

Adamscheck explained for many of the kids who are participating, it is their first time getting to experience fishing, many of whom express interest in continuing the hobby following the derby.

The Town of Strathmore stocks Kinsmen Lake with brown and rainbow trout annually, which participants learn to try and catch. The exercise is catch and release, which aims to teach kids that fishing is not all about killing fish, and there is joy in putting the catch back for somebody else. Bruce Martland, first vice president of the The Wheatland Conservation & Wildlife Association, said the organization also hosts a shooting club for kids to teach them gun safety, among other outdoor activities, all available to participate in for free. "It is to get them out and get the disbelief away from that all hunters are bad people. We are not. We do more conservation to help, (including) releasing pheasants to help their populations," he said. "This is just a small part of it to get the kids out and to experience something different for them." ## Is the Wheatland & Area Hospice Society (WAHS) the same as the Wheatland Housing Management Board (WHMB)?

NO, these are entirely separate entities. While the hospice will share some costs and be located within the same building as the new lodge, it will operate independently with its own board and funding.

### Why not build a stand-alone hospice?

Constructing a stand-alone hospice would significantly increase costs and resource usage. Partnering with WHMB allows us to share expenses, lessening the financial burden on our community and ensuring sustainable operations.

Funding the day-to-day operation of the hospice is very expensive. Reduction of unnecessary extra costs without impacting the quality of care is our primary focus.

### What's the holdup?

Because the hospice will be part of the detailed planning of the lodge building, we are currently awaiting four milestones for this project:

**1.The Grant: AHPP** (Alberta Housing Partnership Program) Government grants are necessary to help make a good business case for low-income seniors housing.

Since their initial submission in October 2023, the WHMB has endeavored to enhance their application. A Class B budget was completed and submitted in May 2024, and meetings with ministers and ministry officials have helped move things along.

## **2.The Mortgage: CHMC** (Canada Housing and Mortgage Corporation)

CMHC advisors are satisfied with WHMB's draft (the pro forma) and are waiting on their provincial counterpart's AHPP grant notification.

Repayment of the mortgage will be paid down by both residents of the new lodge (through their rent) and by us as taxpayers over the next 35 years or so. Increased provincial LAPP grants help contribute paying down this mortgage payments. Most importantly for us as taxpayers, WHMB has committed to total yearly municipal contribution to not exceed \$700k for the entire Town of Strathmore, Rockyford, Standard, Hussar, and the County annually.

## Why can't this project wait?

The current status of our hospice and lodge project demands urgent attention. Significant resources and effort have been invested to bring it as close as possible to breaking ground.

Further delays may incur massive additional costs that could jeopardize the feasibility of the entire project. Future repair costs of the existing lodge and increasing demographic demand for seniors housing urgently requires consideration for WHMB.

For WAHS, a delayed hospice project is a profound loss for our community, as quality residential care, day services, volunteer outreach programs, and grief services are urgently needed.

### What about other players in the game?

Even as for-profit companies endeavor to secure their own projects in our community, there is a fundamental difference in the proposed level of care and affordable services available (lodge vs long term care).

Our community has a growing aging population and these community members need affordable housing. We are confident the Wheatland Housing Management Body's proposal for a new lodge will be successful and hope to continue sharing similar values and vision with them and our community.

Progress was made this spring with AB Health regarding hospice operational funding.

### Who is paying for the hospice build?

The Hospice Society continues fundraising efforts to cover its share of the building costs - estimated at 10% of the total. To date the Hospice Society has raised over \$4.2M to ensure the reality of our vision.

### How can you support?

You can support our hospice project by becoming fully fluent on the choices available and actively vocal about your endorsement of our vision. Reach out to your local councillors to express your support for advancing the collaborative WHMB and WAHS project.

Since Wheatland & Area Hospice Society (WAHS) started in 2015, we have dedicated our efforts to exploring different options for where and how to build and operate our hospice.
