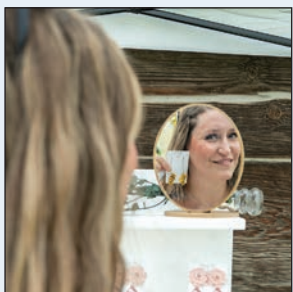

Magnificent markets

Town to add four full-time firefighters

During the May 28 special meeting of Town of Strathmore council, Strathmore Fire Department Chief David Sturgeon petitioned a recommendation to permanently hire four full-time firefighters.

The hiring would be part of the strategic and financially supported plan to enhance the Strathmore Fire Department's emergency response capacity.

Sturgeon's proposal was directly tied to the Wildland Urban Interface (WUI) Program, which was announced last month, and will fund the salaries and benefits of the positions for the first two years.

"Through this grant, the town has secured approximately \$1.09 million in funding, allowing us to expand the service with no immediate tax impact. In addition, revenue from deployment is directed into the fire reserve," said Sturgeon. "Organizationally, this is a proactive step towards a sustainable 24/7 fire service model. Currently, we operate from 6 a.m. to 6 p.m. with full time, and using a composite model after those hours."

Sturgeon explained adding the four new positions would allow the fire department to move towards being fully staffed around the clock, which would improve response times, firefighter safety, and coverage for both local and regional calls through mutual aid agreements.

Through the WUI Program, Strathmore is one of six municipalities that are to receive funding over the next three years to enhance fire protection and response services. An announcement about the program was made May 23 at the Strathmore fire hall.

Golden Hills celebrates approval of new Westmount School development

Golden Hills School Division is celebrating the approval of the new K-9 Westmount School to be constructed in Strathmore, replacing the current half-century-old facility.

The project was approved by the Government of Alberta to move from the planning to the design stage of the replacement school on May 21.

“We were ecstatic to hear the announcement come. We have been waiting for a couple of years to hear this ... we have been in pre-planning and planning mode for a couple of years, and so we had received some government funding for that and we have been working preliminarily with an architect and engineer, and they created a business case and then we presented that back to Alberta Education,” said Jeff Grimsdale, superintendent of schools for Golden Hills School Division. “They liked our business case and what we were doing, then they granted the approval for us to move into the design stage, which will provide more funding and then we will get moving faster, and we are on the school construction accelerator program.”

Grimsdale explained once Golden Hills School Division is ready to begin construction, moving into that phase of the project will be expedited due to their inclusion in the accelerator program.

Currently, there is no formal estimate regarding how long precisely the design stage will take before the project is advanced further.

Preliminary drawings for the new facility have been developed; however, they are still subject to change prior to the project being submitted for tender.

Westmount Elementary School, which serves students in K-6, has been

operational in the community for over 50 years, and according to the school division, is approaching its expiration date.

The decision to have the new facility serve in a K-9 capacity stems from a growing need within the community to accommodate the age demographic.

“It has been an ask for a number of years from Golden Hills to get a new school there ... because of the growth that is anticipated to happen in this area, we decided to put in our plan a K-9,” said Grimsdale. “We are seeing that George Freeman is full, Trinity Christian Academy, the junior high, is full, and Crowther Memorial Junior High is getting to the full stage too. In a few years, they will all be at capacity, so we see a pinch there in junior high.”

The current capacity of Westmount Elementary School is approximately 370 students. Once the new facility is completed, it will have an estimated maximum capacity of 680 students.

Construction of the new facility will see it placed closer to the RCMP building where the baseball diamonds are currently located on the school grounds.

Once students are in the new building, the old structure will be demolished to make room for a new playground. The idea being to not require any student displacement while the new school is under construction.

“When you start looking at the age of the building and whatnot, we know that it just became part of our capital plan that we needed something done with this school, and so replacement is the best course of action for us at this time,” said Grimsdale.

Golden Hills School Division has committed to keeping families and the wider community informed as planning and construction of the new facility move forward.

Strathmore RCMP respond to two incidents that affect local schools

The Strathmore RCMP responded to two matters concerning local schools on May 23 and May 28, respectively, each ultimately being resolved safely.

On May 23, police received a report of an individual who was seen around and entering Strathmore High School with what appeared to be a gun. Members immediately responded to secure the scene and to investigate the report.

Staff Sgt. Mark Wielgosz explained a lockdown procedure of the school was initiated in order to secure the safety of all students.

“We treat all firearms complaints seriously and with the utmost urgency to ensure that we are able to quickly and safely determine what is going on, to identify any offender that might be present, and to bring the situation to a safe conclusion,” he said. “As the investigation progressed, our members were able to identify the individual who was spotted and quickly determined that the ‘weapon’ that was in the student’s possession was a water pistol. It was part of the ‘Senior Assassin’ game that had been ongoing in the school for the end of the school year.”

Weilgosz explained Senior Assassin is a common game which has been gaining popularity across schools throughout the country.

The game involves students assigning each other targets to eliminate from the game with water guns. Rules tend to vary between schools, however the general premise is to be the last student standing.

The lockdown at Strathmore High School was brief, parents and students were notified, and the student who the complained was regarding was briefly taken into custody before being released after the situation had been identified. No charges were laid against the student.

Similar to in Strathmore, the game has led to similar lockdown incidents country wide. Police are making efforts to encourage students who are participating in the game to choose water guns which, as much as possible, do not resemble legitimate firearms.

“Just be mindful of what these activities might look like to others. Ensure that you are not in possession of items that could be mistaken as real weapons, and of course to do it safely – being in crosswalks and traffic and moving vehicles is to be discouraged,” said Wielgosz. “We do not want it to get in the way of people having fun. It certainly seems to be a fun type of game to participate in, we just want people to do it safely.”

On May 28, Wielgosz clarified there was no lockdown procedure that was requested. The incident was a hold and secure.

He explained RCMP received a report that an individual had approached a care worker at a youth facility in an aggressive manner and displayed what appeared to be a firearm during the encounter.

The hold and secure was inadvertently expanded to all of the schools in Strathmore, which he added should not have been the case.

Members responded immediately to the incident and conducted a search of the area resulting in the location of the individual in question who was then taken into custody.

A search of the subject revealed they were in possession of a pellet gun, which could easy be mistaken for a legitimate firearm.

The pellet gun was seized by police, the suspect was transported to the detachment, and two charges were laid. These included one count of mischief, and one count of pointing a firearm.

The subject remains in police custody, and they will make a court appearance at a later time to deal with the matter of bail.

Seniors’ Week focused on Alzheimer’s awareness

June 2 through 8 marks the return of Seniors’ Week in Alberta, which annually serves as a reminder to recognize aging populations.

Seniors’ Week has been recognized since 1986 and is typically hosted at the beginning of June. During this time, the contributions of seniors to enhance quality of life throughout the province is celebrated.

This year, Alzheimer’s Calgary is focused on helping people recognize the differences between normal aging and potential signs of dementia. In particular, notable differences between having a “senior moment” and indications of the disease.

“For example, we all lose our keys from time to time and that can be just natural, and that is not necessarily a sign of dementia. Misplacing things and finding them in unusual places might be a potential sign,” said Barb Ferguson, executive director of Alzheimer Calgary. “For example, you can’t find your keys, and this has been happening more and more frequently, and then you find them in your sugar bowl, or someplace you have never kept them before.”

Frequency of misplacing items and deviations from what would be considered normal behaviour for a person are typically suggestive indicators to keep the potential of dementia at the front of mind.

This may also include experiencing difficulties while completing what would have once been simple tasks.

“If somebody has gone through maybe a significant change in their life, they have been widowed recently or they have moved, that could be causing additional stress and maybe that could be a cause for some decisions that are being made, but it is really important to not take any of these signs as a diagnosis,” said Ferguson. “I think my big message is talk to your healthcare professional about it because they are the only ones who can make a diagnosis, so even though there are signs, there can be other underlying things that are causing those instances to occur.”

Alzheimer’s is the most common form of dementia. Ferguson estimated between 60 and 70 per cent of dementia patients are Alzheimer’s related. Vascular Dementia is the number two cause of dementia.

For residents of Strathmore, Alzheimer’s Calgary has dementia support navigators stationed in town. If anyone has any questions, concerns, or thinks a loved one may be experiencing dementia, they are encouraged to be in touch, free of charge.

Alzheimer’s Calgary also offers a host of education programs both in person and online in order to make information as accessible as possible for rural partners and residents.

Discussing personal safety with children

With the arrival of warmer weather and longer days, kids are spending more time outside – whether walking to a friend’s house, heading to the park, or just enjoying the outdoors. Your Alberta RCMP is reminding parents and guardians that this is a good time to check in with children about staying safe and being aware of their environment.

Building confidence in children to recognize unsafe situations and trust their instincts is one of the best ways to help keep them safe. Having open, age-appropriate conversations about boundaries, decision-making, and what to do when something feels wrong can go a long way in preparing kids for real-life scenarios.

To support families in the community with these important conversations, the Alberta RCMP is sharing a list of tips that parents and caregivers can review with their children:

- Remind kids never to go anywhere with someone they don’t know. Even if a stranger seems nice or asks for help, they should walk away and seek help from someone they trust.
- Let your child know that no adult should ever ask them to do something that makes them feel uneasy. It’s okay to say no and remove themselves from the situation.
- If something doesn’t sit right – even if they can’t explain why – children should be encouraged to leave and talk to a trusted adult as soon as they can.
- Teach kids to check in with a parent or caregiver before accepting anything or going anywhere, especially if it involves someone unfamiliar.
- Help them identify safe adults they can approach if they feel unsure, like a teacher, neighbour, or family member.
- Consider setting up a family password. If someone other than you needs to pick up your child unexpectedly, they should know the agreed-upon word.
- Encourage kids to stick with friends or siblings when walking or playing outside – there’s always greater safety in numbers.
- Walk or bike common routes with your child and point out safe locations they can go to if they need help.

• If your child has a phone, make use of family location features available on most smartphones, like Apple’s Family Sharing or Google Family Link.

• Go over how to use emergency call functions and make sure they know their full name, address, your contact info, and how to describe their location to 911 if needed.

• Run through some ‘what would you do if...’ situations with your child to help them think through different safety scenarios.

Town council approves hiring of four additional firefighters

The most current information available to the Town of Strathmore indicates the discontinuation of the WUI Program in March 2027, at which point the town would be responsible for the salaries and benefits of the four new positions to maintain 24/7 fire service coverage for the community.

“Operationally, we will establish three-person crews to start; it would be 365 days a year, with a goal of expanding to four-person crews as per National Fire Protection Association (NFPA) standard over time,” said Sturgeon. “This significantly reduces our reliance on overtime and paid on-call staffing while improving consistency and reducing fatigue. This proposal also responds to the rapid population growth, possibly 5,000 new homes in the coming years.”

If the WUI program is to be discontinued come 2027, the town would plan for that contingency in the 2028 budget process.

Following an inquiry by Coun. Richard Wegener, Sturgeon clarified any firefighter who desires to be WUI trained and part of the team is allowed to do so, but it is not mandatory.

Of the Fire Department’s 35 current members, 25 are trained to WUI standards, and another three are set to receive the training.

The town passed a motion to approve a 2025 operating budget amendment to adjust for the WUI grant funding over the next two years in a unanimous vote.

Before vaccines were available to prevent chickenpox and measles, parents used to hold parties to expose their children to those with those diseases. Since vaccines to prevent these diseases are available, measles parties are not a good idea. Outbreaks of measles are beginning to occur in the US and Ontario, mostly among unvaccinated children. Measles is very infectious and can be deadly. Best advice? Have your children vaccinated.

Can a vitamin prevent common skin cancers like squamous-cell and basal-cell skin cancers? The answer is yes. Vitamin B3 or *niacinamide* has been proven to reduce the rate of new skin cancers by 23%. Taking 500mg twice daily is recommended. Two cautions: Don't take a related product, *niacin*. Get *niacinamide*. And still use sunscreens faithfully.

The hay fever season is upon us. Plants with fragrant, colourful flowers don't discharge pollen into the air but depend on bees for pollination. These plants are less of an allergy problem than plain plants and grasses, which rely on the air-borne transfer of pollen.

Hay fever symptoms include nasal congestion, runny nose, sinus pain, itchy, watery eyes, itchy nose and throat and sneezing. One of the best non-prescription treatments to combat those allergens causing hay fever symptoms is a cortisone spray called *Flonase*. Just one or two sprays in each nostril once in the morning.

Upcoming temporary road closures needed for essential infrastructure work

Starting the week of June 9, weather permitting, construction will begin on important water system upgrades. This work is part of the Town's plan to improve water service and prepare for the closure of the Brentwood Reservoir.



What the work involves
You may remember last May when the aging trees along Maplewood Drive were removed and a landscape survey was conducted. This work is the next phase in that project.
In 2020, Strathmore's Master Servicing Study found that the Brentwood Reservoir is nearing the end of its life. To prepare for its closure and the necessary upgrades to the Wildflower Reservoir, we need to:

- Build a new watermain connection on Centennial Drive
- Replace and upsize the watermain along Maplewood Drive

These upgrades will boost waterline capacity, ensuring the Town maintains current service levels and adequate fire flows.

Where and when
Construction will happen in six stages. Periodic road closures are expected throughout the summer as the project progresses. Detours will be in place to help you get where you need to go. Here's what's planned so far:

Stage 1
Location: Centennial Drive (from west of Madison Court to the Madison Court intersection)
Dates: June 9 to 11, 2025 (weather dependent)
Time: All day, during construction

Stage 2
Location: Centennial Drive (from east of Madison Court to Maplewood Drive), plus the Maplewood Drive and Centennial Drive intersection up to Maplewood Green
Dates: June 12 to 20, 2025 (weather dependent)
Time: All day, during construction

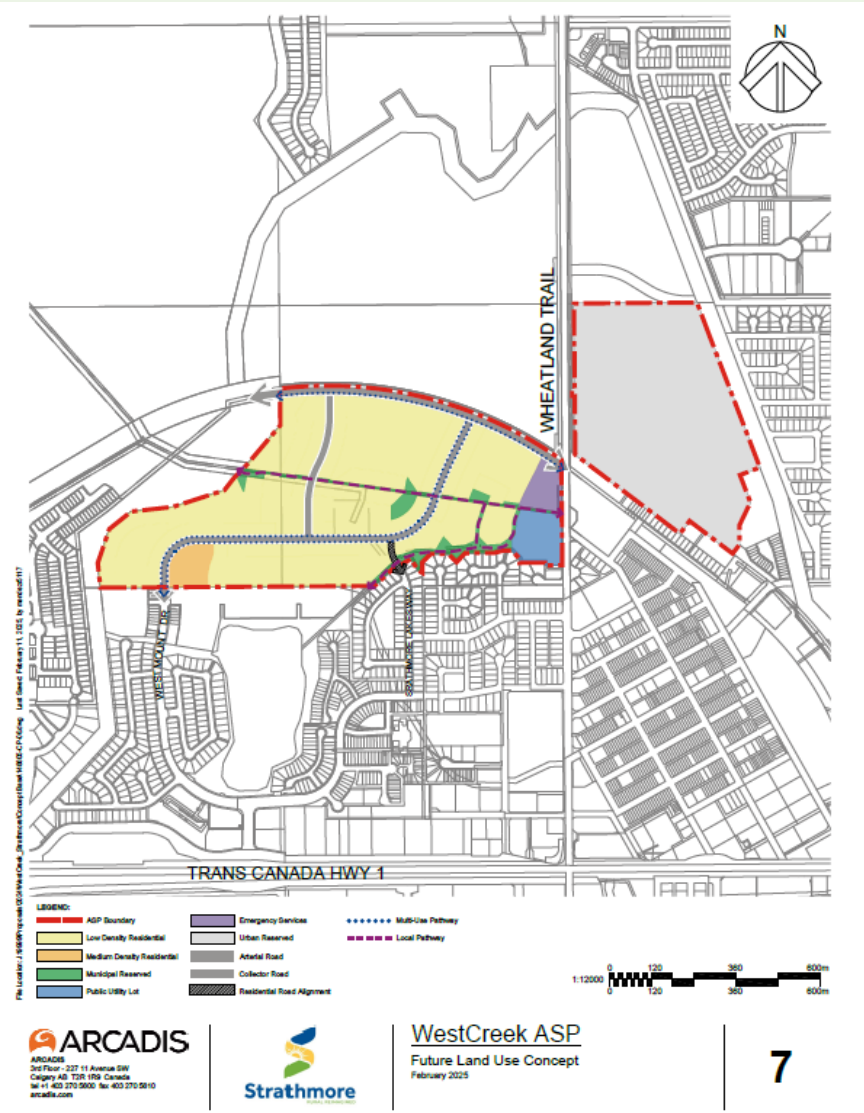

Open House planned for new development

Strathmore Developments is planning an open house, June 10, at the Remuda Building to showcase their Area Structure Plan (ASP) which has been submitted to the Town of Strathmore.

This ASP lays out the framework of the development of Strathmore West, being located west of Wildflower Road and south of Township Road 244.

In all, Strathmore Developments seeks to develop 346 hectares for residential and commercial use over the next several years.

“Our ASP will change the structure plan, will change the (land use) from agricultural to a mix of residential and commercial, and we are hoping to have a bunch of people from Strathmore come out, talk to us, talk to our experts, learn about the project, and that will help us as we ultimately go before council and make a development proposal,” said Neil Sweeney, vice president of communications for Strathmore Developments. “Ultimately it will be determined by council, but we believe once the development is fully done, there could be somewhere in the order of 10,000 people in the development over the next probably five to 15 years.”

Of the 346 acres currently proposed within the ASP, 128 are currently located within Wheatland County.

According to a release distributed by Strathmore Developments, the town concurs with an applicati-



on to transfer the land from the county to the town and has submitted a Notice of Intent to the province to annex the affected portion.

“Obviously, dealing with one municipality, one local government is easier than two, so we have been working with Strathmore on that, and we have been working with our planning department in terms of what information the community will need to make a decision,” said Sweeney. “We have done a number of our studies, typical environment, land use, transportation, those kinds of studies to ensure that we are ready to answer the questions posted by not only people in Strathmore, but town council as the development proposal goes forward.”

He added Wheatland County has been supportive thus far regarding the annexation of the land for the purposes of the project. These lands in particular were chosen as they were available for purchase and being close to Strathmore, currently established amenities will be of benefit to the future community.

The project plan intends to include housing of all varieties, including single-family detached, townhomes, apartments, and condominiums. There is no plan as of yet regarding development of any designated affordable housing units, but the discussion is not off the table.

The information session scheduled for June 10 will begin at 5 p.m. and will run until 7 p.m. Following this, an exact date to meet with Town of Strathmore council has not yet been set.

Freeze on industrial carbon tax

Alberta's government recently announced it will freeze the industrial carbon price at \$95 per tonne through 2025 and 2026 – pausing a scheduled increase to \$110 per tonne. This decision reflects the urgent need to maintain competitiveness, protect jobs, and provide stability in the face of escalating American tariffs and destructive, ideologically-driven policies from the federal government.

U.S. tariffs are driving up costs, disrupting supply chains, and creating uncertainty for Alberta's key industries. Combined with Ottawa's regulatory agenda, this economic climate poses serious risks to our energy sector and resource economy. Now more than ever, we must ensure Alberta industries have the flexibility to operate efficiently and plan for the future with confidence.

Alberta's industrial carbon pricing system – Technology Innovation and Emissions Reduction (TIER) – has been in place since 2007. It is an Alberta-made solution that balances responsible environmental stewardship with economic growth. Facilities regulated under TIER include those in oil and gas, electricity generation, petrochemicals, manufacturing, cement, pulp and paper, mining, and forestry. These sectors employ thousands of Albertans and power our economy.

By freezing the TIER price, Alberta is providing immediate economic relief and certainty to these sectors. At the same time, we remain committed to reducing emissions through innovation, not excessive taxation. Since implementing TIER, Alberta has reduced oil sands emissions intensity by over 22 per cent – even as production has increased by 90 per cent. This proves that Alberta can lead on emissions reductions without sacrificing jobs or investment.

TIER revenues are already being reinvested into next-generation technologies – like geothermal energy, hydrogen development, energy storage, methane reduction, and carbon capture, utiliza-

tion, and storage. These projects are helping Alberta industries evolve while remaining competitive on a global scale.

With a legislated review of the TIER system coming before the end of 2026, Alberta's government will continue to make practical, forward-looking decisions to ensure our economy remains resilient. As the federal government doubles down on policies that threaten jobs and economic growth, Alberta is acting to protect our industries, safeguard livelihoods, and chart a stable course forward.

This is how Alberta defends prosperity, by standing up for our workers, supporting responsible development, and resisting ideological policies that risk our economic future.

A key part of that prosperity is protecting the communities that drive it. That's why I was pleased to join Minister Mike Ellis recently in Strathmore to announce six new Wildland Urban Interface teams, including one with the Strathmore Fire Department. The increase to eight provincial teams will support our regional firefighting capabilities and significantly enhance the province's ability to ensure the safety of Albertans' busi-

nesses, neighbourhoods and critical infrastructure during a wildfire event.

Each new team will be provided with \$1.09 million by Alberta's government over the next two years, for personnel costs, administrative support, equipment and maintenance, and travel costs, to help develop and expand the Wildland Urban Interface (WUI) Program's training and operational capacity.

I have every confidence in the dedicated men and women of the Strathmore Fire Department; they stand ready to answer the call and protect Albertans whenever duty demands. I hold the deepest respect for their service and thank them sincerely for their commitment to keeping our communities safe.

Together, with the dedication of our local fire departments and government support, we are taking decisive action to face the challenges of wildfire season head-on.

Pursuant to the *Municipal Government Act*, being Chapter M-26 of the Statutes of Alberta, notice is hereby given that the Council of the Village of Rockyford will hold a public hearing prior to the second reading of Land Use Bylaw 2025-007. Bylaw 2025-007 proposes to replace the current Land Use Bylaw 2014-002 with an updated Land Use Bylaw (LUB).

An LUB serves as the "rule book" for the development within the Village of Rockyford. The LUB regulates the development of land and buildings on a site-specific basis, based on the policy directions set by the Municipal Development Plan. The LUB regulates how land can be used, including what uses are appropriate and where they can be located. The LUB aims to balance landowner's rights with the interests of the community.

Some of the key changes in proposed Land Use Bylaw 2025-007 include:

- Reformatting and reorganizing the Land Use Bylaw to make it more user friendly;
- Meeting the new requirements of the Municipal Government Act related to development permit processing;
- Increased the clarity on the application process and required content for development permits;
- Addition of Manufactured Homes as a permitted use in the Residential-Detached District (R-1);
- Merged the old Commercial Restricted District (C-R) and Industrial Restricted District (I-R) into the Commercial General District (CG).
- Addition of the Wild Game Bird Hatchery as a discretionary use in the Commercial General District (CG); and
- Adjusted the variances of power of the Development Officer from 100% to 20%. The Municipal Planning Commission will decide on cases requiring greater than 20% up to 100%.

The Village of Rockyford is seeking feedback on the proposed Land Use Bylaw 2025-007. Should you wish to address council in person, a **public hearing for Bylaw 2025-007** will be held in the Village of Rockyford Office at 110 Main Street, on **June 11, 2025** commencing at **6:30 pm**. Mom was born in Canso, Nova Scotia and although she obtained her BSc degree and RN training at St. Francis Xavier University, in Antigonish, N.S., the west was calling. That call led her to Alberta where she worked in both the Red Deer and Lethbridge hospitals. Her sister lived in Strathmore at the time and during one visit, they stopped in at her husband's veterinarian office, where Mom happened to meet Bill Frederick, who had come in with a sick ram. After a whirlwind romance, they married in July of 1955. The following years were spent on the family farm north of Strathmore raising cows and kids! To say life was busy on the farm would be an understatement, with five children being born within the span of six years, farming, taking care of livestock, and building an addition onto the family home, which she and Dad had built together. Life on the farm was certainly not easy back then. Her response to that hard life was "You just did it!"

Mom accepted the offer of Public Health Nurse for the County of Wheatland in 1965, which later expanded to the Drumheller Health Unit, and then realized she had to scramble to get a driver's license! She spent the next 25 years driving around the county doing health clinics, school immunizations, baby clinics, home visits, as well as being one of two people volunteering with the Strathmore & District Ambulance. Mom finally retired in 1990, but then filled her time with many, many volunteer hours with the Strathmore Health Unit, the Hospital Auxiliary Board, the United Church Thrift Sale, and the Strathmore Library. Mom never liked being in the limelight, so when she was honoured in 2007 with the People's First Award through the Calgary Health Region, in 2010 for 25 years of dedicated volunteering with the Strathmore District Health Services, and again in 2022, for 30 years of dedicated volunteering with the Strathmore Library, she was quick to say she just enjoyed people and liked filling her time. We recently learned that it was because of Mom's dropping off of library books to those housebound, that the Visiting Library program was developed.

Mom was known for being the 'Cookie Lady' around town and having her shortbreads for sale at many Christmas craft events. One year she maxed out at making over 1100 dozen of her 'melt-in-your-mouth' shortbreads. People would drive out from Calgary with the sole purpose of getting to her table first before she sold out. Mom was also known for her almost daily walks around the lake. Once she got going with that walker, she was hard to keep up with! Mom kept her mind sharp with the daily crossword puzzles in the Calgary Herald. The day did not begin until that crossword was completed and the headlines had been read.

It's hard to put into words how much Mom will be missed, not only in our hearts, but also in the Strathmore community of which she lived and served for over 60 years. We hope her generosity, compassion, strength, independent spirit, and relentless work ethic will come to mind when people think of Pat Frederick.

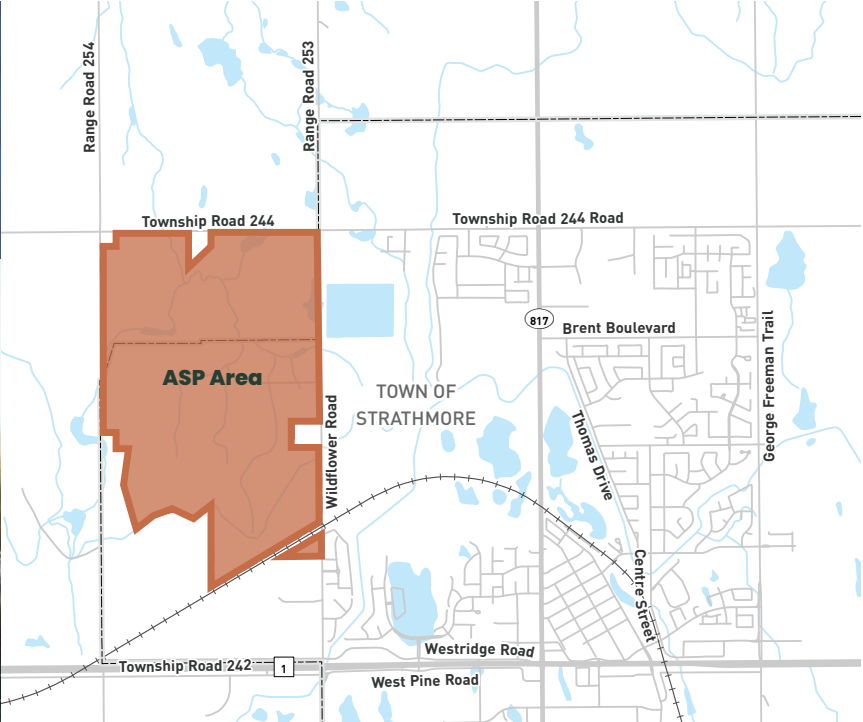
