## Historic settlement signed

The Government of Canada and Siksika Nation met on the Treaty Flats on June 2 to officially sign a \$1.3 billion land claim settlement.

Siksika Nation Chief and Council voted on Dec. 16 and 17, 2021 to accept the global settlement agreement with the Government of Canada to resolve the country's oldest and largest land claim.

Prime Minister of Canada Justin Trudeau spoke during a ceremony to commemorate the agreement at the site of the original signing of Treaty 7.

"We are gathered today to right a wrong from the past. A wrong, as Chief Crowfoot has said before, that should never have happened, and I agree," said Trudeau. "The first Chief Crowfoot ... said that he hoped that the government would be charitable to his people, but as we all know, during the 1910 surrender and subsequent action, the government acted dishonourably."

The Government of Canada at the time of the original 1910 surrender requisitioned 125,000 acres of land from Siksika Nation. Of that, 115,000 acres was sold at auction in 1917. The remaining 10,000 acres was returned to Siksika.

Chief Ouray Crowfoot spoke passionately at the ceremony, commending his council and his people for their resilience and spoke about using the settlement to move forward.

"Canada needs to stop using the word reconciliation. \$1.3 billion, that is a lot of money, but it will never make (Siksika) whole of what it was before," said Crowfoot. "What the \$1.3 billion can do is provide economic opportunities ... and I do see the tide changing for Siksika. I see us becoming a thriving nation."

Crowfoot spoke about using some of the money to develop local education, language support and policing, among other initiatives to build Siksika Nation

"It's not about reconciliation. At this point, it's about moving forward. We're never going to reconcile, you're never going to make it better, you're never going to make it right," said Crowfoot. "Let's just do what we got to do now to go forward. I think Siksika, we have the foundations in place (and) we're moving in the right direction ... there is a bright future for Siksika."

**Bylaw #22-18**

Bylaw #22-18 proposes to amend Land Use Bylaw No. 14-11 by redesignating a portion of NW-22-24-25-W4M in Lakewood as listed in the map below.

The 0.199 acres of R1N to P1 is to accommodate a proposed park. The Direct Control District Overlay proposes to reduce the minimum side yard setback for internal lots (lots other than corner lots) from 1.5m to 1.2m in this phase of development.

**Public Hearing Process**

A copy of the proposed Bylaws may be inspected by the public during regular office hours, 8:30 a.m. to 4:30 p.m., Monday to Friday at the Town Office (1 Parklane Drive, Strathmore, AB), or can be found on the Town website (<https://strathmore.ca/en/town-hall/public-hearings.aspx>). Please contact the Town Office if you would like an opportunity to review and provide input on the proposed amendments prior to the Public Hearing.

The Public Hearing will be held via ZOOM and in Council Chambers on **Wednesday, July 6, 2022**, commencing at 6:00 p.m. with procedures in accordance with the Municipal Government Act, Section 199 and the Town of Strathmore Council Procedural Bylaw #22-18 and amendments thereto. Any person or group of persons, or person acting on someone's behalf, who claims to be affected by any or all the proposed bylaws may present suggestions or concerns by making a submission to the public hearing. Please contact Johnathan Strathdee at [johnathan.strathdee@strathmore.ca](mailto:johnathan.strathdee@strathmore.ca) by 12:00 noon on Wednesday, **June 29, 2022** in order to register to present. Each person wishing to address Council at the Public Hearing shall complete their verbal presentation within three minutes.

Written submissions to the Public Hearing or the name of any person wishing to make an oral presentation at the Public Hearing must be received by the Planning and Development Department prior to 12:00 noon on Wednesday, **June 29th, 2022** as outlined in Bylaw #22-18 amendments thereto. If your written submission is not received by this time, please

provide fifteen (15) copies for distribution at the Public Hearing. Each person wishing to address Council at the Public Hearing shall complete their verbal presentation within three minutes. Please note that written submissions will become public documents once submitted to the Town, unless otherwise requested.

# Police investigating sudden abduction of local youth

Strathmore RCMP are conducting an investigation to identify two suspects following the abduction of a female student on May 31.

According to Strathmore RCMP Staff Sergeant Mark Wiel-

gosz, police were notified at approximately 6 p.m. that evening after a family member located the female student, after she had escaped her abductors.

“The details that we have learned was that a young female student, after being dropped off from her school bus, was walking towards her residence when she encountered two males with a white pickup truck who forced her into the vehicle and took her to a residence,” said Wielgosz. “It was from that residence she was able to escape from the two males and make her way back towards her home. She was later found by a family member who had been out looking for her, which is when the police were called.”

An investigation into the two suspects is currently underway and the RCMP is seeking any information regarding the two individuals.

One is described as a male with light coloured skin, clean shaven, long blonde hair and blue eyes, who was wearing a black toque and black Zoo York sweater.

The other, a male with light coloured skin, clean shaven who was wearing a white shirt and grey sweatpants.

The vehicle in question, which was used in the abduction, is described as a four-door white truck with a grey interior.

For the privacy and safety of the family, the victim will remain unidentified.

“Our members immediately responded and commenced an investigation of what occurred. The young female was taken to the Calgary Children’s Hospital as a precaution for medical examination and was later released that same day,” said Wielgosz. “We want to make sure that we are able to conduct the investigation and collect as much evidence as possible to determine exactly what happened and then to hold those responsible accountable for what happened.”

If the public has any information, call the local RCMP detachment to report what they might have, which will be passed on to the investigators.

If someone wishes to remain anonymous, they can submit information via Crimestoppers.

If a member of the public believes they have a sighting of a suspicious person, the RCMP’s recommendation is to not interact with the person and to instead observe what they are doing and make note of distinctive information.

“We have increased our presence within the community to provide those levels of reassurance to our residents that their police service is out on the road looking after the streets and trying to maximize public safety,” said Wielgosz who wished to remind parents to have those conversations with their kids regarding general safety practices, have a plan of where kids

are going and to stay updated as to where they are.

If a child feels as though they are being followed, or they feel uncomfortable, get to a location that is well lit with lots of people such as a local business or store where assistance can also be called.

“It is unusual. I am not aware of any similar incidents that have occurred since I moved down here in 2015,” said Wielgosz adding that an incident like this is extremely uncommon in Strathmore. “This does involve one of our Strathmore youth who is one of our own and it is something we do take very seriously. Fortunately, our young female victim was able to escape and was not harmed any further.”

## Carseland medical student awarded \$5,000 scholarship

Breanne Gordulic from Carseland, currently studying medicine at the University of Calgary, is one of four recipients of the 2022 Rural Health Professionals Action Plan (RhPAP) Rural Medical School Awards.

The award is effectively a \$5,000 scholarship, awarded to four students of medicine annually who have expressed interest in practicing medicine in rural areas.

“It basically covers anything you need, like tuition, transportation (and) any kind of school supplies. Some of the criteria for winning the award were the intention to help out in a rural community and (evaluating) your interest in rural medicine,” said Gordulic. “It’s pretty amazing and super motivating. Commuting back and forth from school can be tough sometimes because I still do live out here, I never moved to Calgary for school so it helps out with things like that.”

Gordulic elected to utilize the award money to help cover the costs of her tuition, which, as any graduate of post-secondary education will attest, is not cheap.

**BBB Tip: When you need help, use these tips to contact customer support**



Calling customer service is often a frustrating experience. You are put on hold multiple times only to find out that no one can help resolve your problem. Plus, with multiple customer service scams out there, even getting in touch with customer support can pose a challenge. Whether you need to cancel a subscription service, ask about an unexpected charge, or get help with a technical issue, the following tips can help you have a better customer service experience.



- Need customer service help? Follow these tips:**
- **Think about customer service BEFORE you do business with a company.** Evaluating a company’s customer service before you do business with them can save you a lot of headaches down the road.
  - **Prepare before you call, email, or chat.** Before you contact customer service, do a little research on your problem. Visit the company’s official website (double check the URL to make sure you aren’t on a fake website) and look for an FAQ or troubleshooting page.
  - **Make sure you have the right number.** Before you dial up customer service, make sure you have the official number. Fake tech support number scams have claimed many victims.
  - **Have your information on hand.** Have any account details you need ready to go, including order numbers, account numbers, and any other details that are relevant.
  - **Be careful with your personal information.** According to one study, 56% of customers don’t mind sharing their personal information in exchange for better service. You may need to share some information with your customer service rep.
  - **Call when wait times are shorter.** According to Talkdesk, early in the morning and Wednesdays and Thursdays are the best days to call customer service. They found that customer service is 7% faster on those days than on other weekdays.
  - **Take notes.** Ask for a ticket or reference number when you speak with customer service.
  - **Escalate, if you must.** The first person you speak with might have limited power to help you, depending on the issue.
  - **Always be polite.** Even if you need to speak with a manager, always treat customer service representatives with respect and kindness. You’re much more likely to get your issue resolved this way.
  - **Be wary if customer service contacts you out of the blue.** Legitimate companies don’t make unsolicited phone calls. Scammers do.
  - **Offer feedback.** If a customer support agent gave you amazing service, leave the company a good review. Conversely, if you had a poor experience and especially if you suspect shady business practices, file a complaint on BBB.org.

# Town advocates for more Indigenous awareness in public education

The Town of Strathmore is advocating for the Government of Alberta to provide funding and resources to allow Indigenous elders and knowledge keepers to share their experiences in the public education system.

On May 30 the Town held a Special Council Meeting to discuss a proposition to advocate to the province in support of Indigenous awareness training and support.

Denise Peterson opened with a motion that the Town of Strathmore bring forth the resolution entitled "Provincial Indigenous Awareness Training and Support" for consideration at the 2022 Alberta Municipalities Convention in the fall.

"This is related to the discussions that have been ongoing that originated with Siksika Councillor Herman Yellow Woman in 2015, where they talked about the necessity of bringing lived, experienced voices into the education system," said Peterson. "The reasoning behind that is ... until very recently, (there was) a lot of conversation about deficits in our curriculum, in terms of how we related issues of Indigenous history in this country."

Town administration described it as imperative in the public agenda package that residential school survivors be allowed to share their lived experiences and stories within public education.

Peterson, in addressing her motion, said there is a deficit of authentic voices – referring to such survivors who have been able to share their ex-

periences.

"One of the things that continued from this and in conversations with Butch Wolf Lake, who did our training, was this small thing that we could accomplish to urge our provincial government to envelope funding in Alberta education for schools, school's jurisdiction and homeschoolers to be able to access those authentic voices and learning in support for curriculum," said Peterson. "For instance, today we have in the Alberta curriculum, Blackfoot language and culture, we have aboriginal studies, but one of the things that teachers have said to me over the last four years ... is that they do not have funding or access to bring in those authentic voices to speak to those issues."

"In order to get proper sentiment ... right understandings and sound and solid information, having access to these people is very critical in the truth and reconciliation ... process," continued Peterson.

As a point of clarification, Peterson noted the Town is not suggesting the province add additional funding to that which already exists.

"We are not asking taxpayers to pay more money to this end, we're just asking for mindfulness around dedicating something that they would determine would be reasonable to allow schools and jurisdictions to bring this forward," Peterson explained.

The motion was carried unanimously. Strathmore will also be forwarding the resolution to the Village of Rockyford for their council to consider seconding.

# Summer reading programs return to library

The Strathmore Municipal Library is once again hosting its summer reading programs and is excited for them to effectively return to normal.

Last year, although programs were allowed to be hosted in person, gathering for activities had to be held exclusively outdoors. With COVID-19 restrictions now lifted, programs will return to business as usual.

"We have a theme for our camps here, which is 'once upon a time,' so we are focusing on activities based on fairy tales and myths and legends, which is now structured into different age groups that will meet once a week at different times, doing activities such as games and crafts," said Jeannie Nelson, one of the library's summer reading program coordinators.

"We also have our teen summer reading club that's going as well, so that will be Thursday afternoons, which will be part of the summer reading program but there will be a little bit of a different structure," added Luke Schramm, who is working alongside Nelson.

Schramm explained the theme of the summer reading programs is handed down from TD, who organizes the programs in general, but that the library coordination team breaks the main idea down into subthemes for participants to engage with every week.

Seven weeks of programming will be hosted at the library over the course of the summer, with each week being themed differently under the fairy tale and fantasy umbrella. These will include a mythical creature week, magic week, and so on.

Youth within the community who chose to participate will be split into four age groups: kinder-

garten to Grade 2, Grades 3-4, Grades 5-6, or the teen program.

The library will also be hosting community events every Friday, that will be open to people who are not in the program, however according to Schramm, those events are very much still in the planning stages.

"Alongside the weekly activities, kids can do reading logs which also enters them into the opportunity to win prizes depending on their reading minutes," said Nelson. "When there is a more attainable goal, it makes them more motivated to read and it doesn't feel like school, or that they need to get something done."

Schramm said the goal of encouraging youth to read is to maintain and practice their literacy and show kids the joy of reading without it feeling like a chore or a return to school over the summer.

"Lots of times, that can slip for kids in the summertime, so we want to make sure they are having fun staying on top of that in a really low stakes way," said Schramm.

According to Karissa Carlson, who rounds out the summer reading program team alongside Nelson and Schramm, the program hosted last year saw roughly 120 local youths signed up, excluding those from the teen program.

Kids are encouraged to register early as time slots will initially be capped at 30 kids to allow for ease of organization.

People within the community aged 13 and older are encouraged to volunteer and can do so online or in person. Teens can both volunteer as well as participate in the teen reading program.

Registration opened on June 4 and more information can be found on the summer reading program page on the library's website.

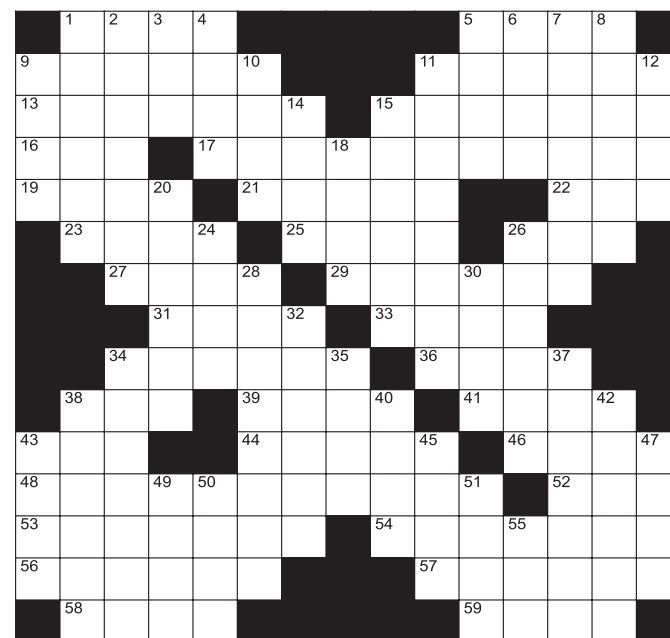

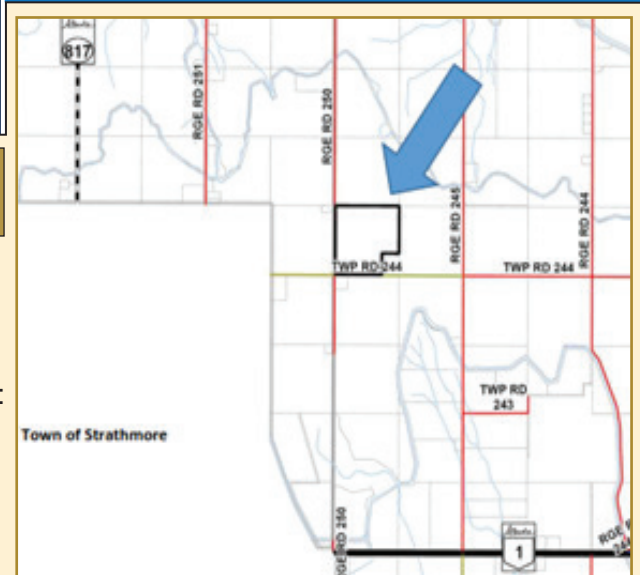

“Tuition for medical school is very expensive and it really does help because right now I’m not working. It’s not really a great idea for me to work while in school. It really helps relieve that little bit of the financial stress,” said Gordulic, who explained that her decision to go into medicine was a longstanding goal, as her parents were both pharmacists prior to their retirement.

Gordulic added her drive to practice in a rural community is to make an impact for those who might otherwise have to travel to a major city for medical care, similar to herself.

“I actually did not go straight into medicine, I had a whole career before

this and worked in oil and gas. How I made my switch, I ended up moving out here rurally and had a hard time finding a doctor for myself,” said Gordulic. “That includes a family doctor and a specialist, so that kind of got into my head ... if I decided to go into medicine, I can make an impact in my community.”

Gordulic continues to reside in Carseland as she attends classes at the University of Calgary and has expressed interest in practicing specifically in town as opposed to another rural community post graduation.

“If I have trouble finding medical care, I can’t imagine what anyone who has any number of barriers, the struggle, they must feel trying to get proper care,” she said.

Mask-wearing in Japan has a hundred year old history. When Covid hit, the Japanese didn't have to be ordered to wear masks. Many already were and knew the positive effects of mask-wearing had on preventing the transmission of diseases like colds and flu.

Each summer, people look for “natural” insect repellants. Taking extra vitamin B1 (thiamine) was not effective as a repellant. Others like lemon grass, citronella, peppermint and rosemary have mixed results. Products containing *picardin* (a synthesized chemical made to mimic a compound in the pepper plant) is one of the best repellants. Another that did have a seal of approval from the EPA and Consumer Reports was *Oil of Lemon Eucalyptus*, not to be confused with lemon eucalyptus oil.

Did you know only the female mosquitos bite? They need blood for nourishment but the males feed on plant nectar. Mosquitos are attracted to sweat, dark clothing, body odour and of course the carbon dioxide we breathe out. Not too much can be done about the latter but work on the rest and use a repellant proven to work.

A common complaint that women express against quitting smoking is possible weight-gain. Weight-gain can happen but this gain in weight doesn't last forever. The act of quitting smoking is a good health decision that will continue to give benefits for a lifetime. Remember, cigarette smoking is the single most preventable case of death and illness.

# Brentwood Elementary Students fundraise for Ukrainian family

Brentwood Elementary students came together to raise money for Ukrainians in need as they learned about what it means to be global citizens.

“So, the Grade 3 curriculum, they (the students) learned about different countries, Ukraine being one of them, and then also learned about being global citizens and Canadian Citizens,” said Amy White, who teaches at Brentwood Elementary. “(When) the news hit, my kids felt like they knew about Ukraine and felt it was horrible and they wanted to help and do something.”

After a bit of planning and brainstorming, White’s students settled on wanting to do a fundraiser to contribute and make a difference for somebody.

According to White, students and families were asked to bring in two-dollar donations to the cause, or any other donation the community wished to put forward.

The single-day fundraiser, hosted in May, was able to bring together \$2,780.

“We were impressed with the amount that we were able to get out of such a small school. After that, we also did an awareness and education campaign in our school,” said White. “The fundraiser was online and that allowed us to tell our kids a little bit about it ... and then we found a family who just moved into Calgary who were displaced due to the war.”

White explained the money was donated to the family, who after only recently finding a new home, informed Brentwood Elementary of their intent to use the money for furniture and a few

children’s toys.

Though the official fundraiser was only hosted for a day, the school collected donations for roughly a week for families who wished to contribute.

“There was no goal, it was just to bring what we could. And, we didn’t have a family picked out yet, we just knew we wanted to help a local family, if possible,” said White. “We knew that families were going to start to come over, so we thought let’s get prepared for that and it was amazing to see how much Brentwood came together to make it happen.”

White added the process turned into a unique hands-on learning experience for her students to experience firsthand what it means to be global citizens and apply their learning.

“It really made it tangible for them to understand what was going on, and ... I would say it’s kind of taking the learning from outside our school and putting it inside, which was a really nice combination,” said White. “If you teach what the words ‘Global Citizen’ mean, it doesn’t mean anything if (students) are not actually experiencing ... what the family was going through.”

## Platinum Jubilee display

To celebrate Queen Elizabeth II's Platinum Jubilee, The Vault Cultural Collective is hosting a display of memorabilia depicting the British royal family.

The Queen's Jubilee marks the 70th anniversary of her accession to the British throne. She is the longest reigning monarch in British history.

The previous owner of that distinction was Elizabeth II's great-great-grandmother, Queen Victoria, who reigned for 63 years prior to her death at the age of 81 in 1901.

The collection of memorabilia on display at The Vault was provided by collector Lynne Fair, who said she is an avid enthusiast for anything relating to the British Crown.

"I've always had British roots and have always been interested in the monarchy. I was definitely around when there was the coronation," said Fair. "(My collection) was assembled very, very slowly over a lot of time. I tend to be a collector anyways and I'm often at collection sales."

Fair said she makes a habit of adding unique articles to the collection whenever she comes across a new piece.

Many of the pieces within her collection, she explained, are the only ones of their like she has come across.

The collection dates back to Queen Victoria, with memorabilia of the royal family including up to more recent pieces bearing images of the Duke and Duchess of Cambridge, William and Kate.

"They didn't even all come down to The Vault or fit in here, but I have a lot of books that I have done some research on, and I'm really pleased to see them all in one place," said Fair. "There is another generation or two to come along and since Prince George and I are sort of, of the same vintage, I hope that after all the years of waiting and training, that he gets a short chance at least to be the king before William takes over."

Fair added she is unsure of just how many articles comprise her entire collection, which began in 1953 upon acquiring items from the Queen's coronation from a relative in England.

The Platinum Jubilee was celebrated from June 2-5 and was celebrated by former British colonies across the globe.

"This Platinum Jubilee is a first ever and there probably will not be another one for anybody to reign for 70 years," she said.

Those who are interested in viewing Fair's collection can drop into The Vault during its regular open hours. The display will remain in place until November.

Wheatland Housing Management Body (WHMB) is continuing their work and planning for a new senior's lodge in Strathmore on the property East of Kinsmen Lake. The WHMB building committee is currently focused on the financial aspects of the proposal and are engaged with their planners in working out details for a sound, affordable plan that will serve the citizens of Strathmore and Wheatland County for many years into the future.

It looks like the new Langdon High School is coming along. This \$43 million project will be able to accommodate up to 925 students in Grades 7-12, with room to expand to 1,225 students in the future. “Chief Billy Morin said the new Sovereign Medical facility will meet all medical standards while also being a chance to offer services to both Indigenous and non-Indigenous patients, including those who might feel uncomfortable in a standard hospital setting.” (Ashley Joannou, June 01, 2022, The Edmonton Journal)

## Bills C-11 & C-18 - the Internet regulation bills

Bill C-11 is once again receiving a lot of attention. From media to concerned Canadians, the wide array of opinions has made for quite a conversation. This week alone, the standing committee on Canadian Heritage is meeting for 20 hours on Bill C-11 alone. This emphasizes the importance of this bill and the potential impact it will have on Canadian content, Canadian internet and the Canadian media landscape in the future. In the previous Parliament, we were successful in stopping bill C-10

The government insists that individual content posted online is exempt from this bill, but according to several experts including University of Ottawa Professor Michael Geist say that ‘user generated content’ (UGC) is in fact still subject to regulation by this bill.

Even the chair of the CRTC Ian Scott admitted

during committee testimony that user generated content would be included in this bill (source: <https://www.michaelgeist.ca/2022/05/crtc-chair-confirms/>)

In the same vein of Bill C-11, C-18 also contains provisions to do with the way online content is distributed and consumed. The bill requires compensation for facilitating access to news in any way and in any amount.

According to Professor Michael Geist: “Bill C-18 is a shakedown with requirements to pay for nothing more than listing Canadian media organizations with hyperlinks in a search index, social media post, or possibly even a tweet. At a time when we need the public to access to credible news, Canadian Heritage Minister Pablo Rodriguez believes that large internet companies that engage in the act of facilitating access to news – not copying, not using, not even directly linking – should pay for doing so.

“Bill C-18 is shamefully over-broad, an embar-

## RCMP expands response for Sexual Violence Awareness Month

**ALBERTA RCMP**

In a commitment to ensuring a victim-centred and trauma-informed response is provided to all survivors of sexual violence, the Alberta RCMP is expanding its response to sexual crime. With new, dedicated teams and positions across the province, and a new web page with tools and information for the public, the Alberta RCMP is highlighting the importance of understanding the impact of sexual and domestic crimes in our communities during Sexual Violence Awareness month.

Sexual Violence Awareness for the month of May began in 2018 when the Government of Alberta launched a commitment to working towards ending sexual violence. On average, there are about 2,500 calls for service relating to sexual violence each year. In 2021, there was just over 3,000 sexual offences reported to the Alberta RCMP, which was an increase from the previous year.

Having specialized teams in place for sexual violence occurrences has proven to be valuable for centralizing service and having specific expertise to support survivors. In 2020, a Specialized Investigative Unit was piloted in Grande Prairie and surrounding areas to focus on investigating sexual assault and domestic violence offences. After a successful pilot year, the team is now in full operation and the Alberta RCMP are implementing similarly focused teams and positions across the province.

In working with and responding to survivors of sexual violence crime, education and understanding about the impact of the crime and the needs of survivors is vital. The Alberta RCMP has set up a new web page with detailed information for the general public and a centralized location for resources for survivors: <https://www.rcmp-grc.gc.ca/ab/community-communaute/sa-as/index-eng.htm>.

The Alberta RCMP has also established important relationships with community sexual assault centres

and other partners to allow for more comprehensive service for the survivors of sexual assault including support for children and youth. The dedication of our community partners is vital to the work we are doing collaboratively to support survivors and bring awareness to the public.

“Being a voice for sexual violence is being a voice for generations to come. Our work is crucial to ending the crippling effect of trauma associated with these crimes of power and control,” said Corporal Courtney McCarron, who recently attended the International Conference on Sexual Assault, Domestic Violence, and Reimagining Justice in San Francisco. “We need to support victims and they need to always know that the assault is never their fault.”

If you are a survivor of, or witness to, sexual violence or any criminal activity, please report it to local police or contact your nearest sexual assault or community-based Victim Services agency for appropriate support and reporting options.

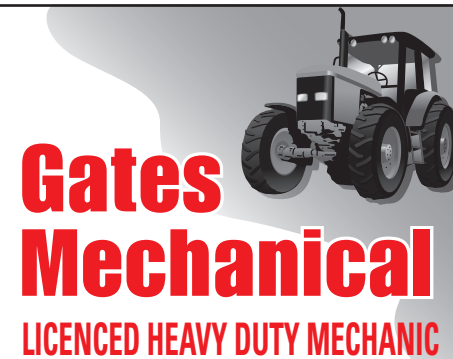

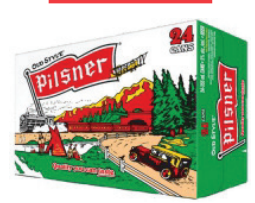
