Handi-Bus negotiations continue

Negotiations are moving forward between the Strathmore Handi-bus Association and the Town of Strathmore over a Memorandum Of Understanding (MOU) between the two organizations.

The Handi-bus Association brought forward an amended document to Town Council during the March 2 regular council meeting, which was then referred to administration.

The amended MOU brought forward by the Handi-bus Association had made changes to the agreement regarding the bus barn building and simplified the language used describing the agreement.

According to the Handi-bus delegation, the organization didn't think it was particularly relevant to the relationship between the Handi-bus and the Town.

"I'm assuming if the bus barn value is going to cost us money to move it, I'm assuming the cost will be borne by the Town, because I can't imagine that it's worth anything," said Councilor Denise Peterson.

"I just want to make sure that the Handi-bus isn't liable if it costs us money to get rid of it."

The Handi-bus delegation confirmed that during a prior discussion with council and administration, the Town's previous CAO indicated there was not a significant amount of value in the structure in question.

The revisions also more explicitly delineate the understanding and responsibilities of the Handi-bus to the Town of Strathmore in paragraph "D" where expectations of the Town are outlined.

Those expectations of the Town being to help cover the association's operating losses up to \$175,000 annually. If the Handi-bus does not use all the funding received from the Town, any leftover capital would then be returned.

'We're hoping to foster more goodwill between the Handi-bus and the Town of Strathmore. I think we can see from events around the world what happens when there is insufficient amount of goodwill in play," said Brian Grier, chair of the Handi-bus Association finance committee.

Grier added regarding the potential of a rebate to the Town, the idea being that should the MOU pass, to review the Association's audited financial statements with the Town and agree on a number.

The Handi-bus delegation did specify that they would not be able to reliably continue operations without being backed by the Town, though does not expect to require municipal resources to cover the costs of any additional busses.

Administration was directed to return to Town Council on March 16 to further discuss the MOU.

Siksika Nation encouraging First Nations peoples to share stories of racism in Alberta health care

Siksika Nation Chief and Council are taking actions to address systemic racism against First Nations peoples in Alberta healthcare facili-

Chief Ouray Crowfoot said during a press conference on March 4 that Chief and Council had unanimously passed a motion to authorize the JFK Law Corporation to conduct information-gathering interviews with Siksika Nation members.

"A steady flow of complaints has been made to Chief and Council in this area and leadership is working with a team of lawyers on this matter," said Crowfoot. "For too long we have been subjected to racism (and) discriminatory behavior while receiving health care. For too long we have been insulted when we were at our most vulnerable by people seeking to take advantage of us."

According to a press release, the interviews may be used to assist in potential litigation for the protection of Siksika Nation members and their families while receiving healthcare.

A notice distributed to Siksika Nation members was

written to inform them of information-gathering sessions and that anyone who has been discriminated against, or has been treated negatively based on race, ethnicity, or status as a Siksika Nation member, or has witnessed a racist or discriminatory incident at an Alberta healthcare facility, is invited to come forward.

Any indigenous people who wish to reach out to Siksika Chief and Council regarding their stories of discrimination within the healthcare system, will be treated with absolute confidentiality for the respect and safety of the individual who decides to share.

"There are there's a lot of great work that's going on in the Alberta healthcare system. We're not here to attack the Alberta healthcare system but we're here to make sure our people are treated equitably in the healthcare system," said Crowfoot. "We can no longer be the ostrich and put our head in the sand and hope when we get it back up, everything's going be good. If you want to make tough change, real change, you have to have the real data."

During the press conference, Councillor Samuel Crowfoot said it is impor-

tant that people's stories are heard, are listened to and believed.

"Racism isn't new. It's only now that it is with the prevalence of cell phones and digital cameras (that it is) finally being recorded," said Crowfoot. "The complaint process in general Alberta, for any type of medical issue, or any type of racist or derogatory event, is extremely hard to follow and is governed not in the most efficient way. Thereby, I think it reduces the amount of complaints that come in because of the process."

Siksika Health Services CEO Tyler White added he is disappointed these types of measures are necessary in order to get the attention of the provincial and federal governments.

"I'm reflecting with sadness. I'm also reflecting with hope that today, as I said, is a day of action to be able to address those long-standing issues of racism and discrimination," said White. "I'm also reflecting on the experiences of our people. And these aren't just stories, these are real experiences that our people have experienced in the hospitals in the emergency departments."

According to White, on the same day the service was available for Nation members to come forward with stories, people began to make use of the service.

Information will be available through the Siksika Chief and Council website about how to reach out and for Nation members to share their experiences.



New Blood live show returning to Rosebud Theatre

Rosebud Theatre and School of the Arts will once again be hosting New Blood, a story told through dance, choreographed by Strathmore High School's Deanne Bertsch.

"New Blood is a show that is about Chief Vincent Yellow Old Woman, he is a former chief of Siksika Nation. It's his story of growing up in (a) residential school and then struggling with addiction, and then healing and becoming chief of his people," said Bertsch.

She explained the inspiration for the show came in 2014 following a trip to Writing-on-Stone Provincial Park, where Bertsch spent time viewing native pictographs and listening to stories from her tour guide.

Being somebody who works with many Siksika students at Strathmore High School, Bertsch said she was "saddened and horrified" to learn that the stories behind many of the pictographs had been lost, greatly due to the impacts of residential

From that experience, Bertsch was compelled to create a show with her dance class which told a history of the Blackfoot people.

"We interviewed a Blackfoot teacher at our school named Eulalia Running Rabbit and she just talked about the moments in history that changed the way of the Blackfoot people," said Bertsch. "We started creating the show and it was a little about the fur trade and a little about residential school and reservations ... but because it was a dance class, we told it all through movement."

Lacking direction for her story, one of Bertsch's students at the time suggested she call his grandfather, who after sharing his personal story, shared a poem with Bertsch called The Indian and the Child, which came to be the story the

show is based upon.

This is the second time Rosebud Theatre will showcase New Blood, the first time being in 2016. Bertsch said this year's cast is the "12th or 13th" who have participated in retelling the story.

"Rosebud (School of the Arts) has asked me to do it with their students, so they are learning the part of the spirit dancers. The spirit dancers are animal spirits that are sort of the protectors of the Blackfoot children who are in residential school," added Bertsch.

"The students who are playing the residential school children, all of them have parents or grandparents who went to residential school, so they are actually playing their parents or their grandparents in the show."

The soundtrack for the show is taken from Peter Gabriel's album of the same name, New Blood, which was originally produced in the 1980s.

New Blood will be performed at Rosebud Theatre from March 18 to 20.

U14 AA Ringette takes silver at provincial championship

Strathmore's U14 AA Ringette team has claimed silver at their provincial championships, earning them a spot at the Western Canadian Championships later this month.

Jody Nouwen, coach for the U14 AA team, said it was close to what one might call a "Cinderella story", as the team went into provincials standing fifth place in the league.

We went into the round robin and played four games and we were undefeated. Some would say we were kind of the underdogs going in, who peaked at the right time," said Nouwen describing her girls as the underdogs of the tournament.

"We ended up in a fairly tough pool, playing the top place team and then ... the third-place team ... there were some teams we've had close matches with before but never (quite) pulled the win out."

In the gold medal game, Strathmore's representing team lost to another team who they had previously defeated in the proceeding round robin.

Nouwen said the tournament was a very close set, with any of the top six teams having the potential to win it all.

"With the play in provincials, it could be anybody's game. The teams are really close. Any one of us could have been seeded one-throughsix quite easily," said Nouwen. "On the Sunday, it wasn't our day, but we definitely have another crack at them, likely at the Western Canadian Championships down in Regina (Sask.) at the end

Nouwen praised her team for their hard work over the course of the season and ensuring that their goal of, at a minimum, standing on the podium of every tournament, didn't go unmet.

In the tournaments prior to provincials, the team managed to take home one bronze, two silver and one gold medal.

For some of the girls, she added, it was their first time taking to the ice on a provincial stage.

"For them to go there and do as well as they did ... it really helped them believe in the process and believe in the spirit of the game and believe in themselves as a team," said Nouwen. "We don't have as many kids trying out for our AA program. So, when you're able to pull those athletes out and then be able to compete against some of the teams that have way more kids in their community trying out, that just goes to show the quality of program that we have."

Nouwen firmly believes her defence-oriented team has a good shot to bring home the gold from the Western Canadian Championships in Regina Sask. set to take place from March 31 to April 3.

Local curler turns 94, hopes to get several more years on the ice

Celebrating his 94th birthday, Lido Kondo is still enjoying the sport of curling, 70 years after first taking to the ice.

"I think I started way back in 1952. Some of my friends got me (into it) way back then. I really liked it, so I stuck with it," said Kondo who added that he was never one to be competitive with his curling, save for the odd bonspiel and seniors' league at the curling club.

"I like the friendship. We just curl for the exercise and just to be with our group, with other curlers and having a good time," said Kondo. "I'm pretty lucky that way. I really like the game and I hope I can go for a few more years yet, I don't know. I'm kind of lucky that way that I can still do it."

Kondo's daughter, Colleen, said although her dad never lost the love for curling, it was far from the only sport that has kept him active over the last 70 years.

"He square danced quite a bit from 1975 to about 2010 and after that, he was always golfing. When he quit golfing because of his shoulder, he ended up jogging in the mornings instead," said Colleen. "He was in the opening ceremonies ... in the 1988 Winter Olympics square dancing group. They formed the prairie rose, the group of them."

Colleen added Kondo had also spent time taking up cross country skiing among his other sports of choice. She suspects that her dad has been able to continue being involved in sports simply because he doesn't stop moving.

She also described Kondo as a lifetime community member who was often volunteering where he was able.

Back when Kondo first started curling, athletes made use of natural ice rather than the artificial arenas that are used today. Colleen joked that when chinooks rolled through town, her dad and his fellows would have to wait for the ice to refreeze before they would be able to finish games.

After concluding their activities on the ice for Lido's birth-

know there's still a lot left with the pandemic, but it's nice to get back playing for live audiences again."

Paulson said although the band did several performances in the United States, where the use of masks was not mandated, it feels unusual to be performing in Canada and experiencing a sense of pre-pandemic normalcy.

Paulson said the group originally formed very innocently from a handful of guys who just wanted to get together and play some bluegrass music.

Art show at library

A new artist is now showcasing her work at the Strathmore Municipal Library, which will be hung and for sale throughout the month of March.

Sibil Simmons is still relatively new to her medium, but now that she has found joy in painting, it's something he has no intention of stopping any-

"A year ago, I picked up a paintbrush and it's a story of me getting back on my feet," said Simmons.

"I like to paint anything and everything. If there's something I want to paint, I'll teach myself. I'll just paint and paint, I'll use one canvas over and over until I get it right ... I paint because it helps me heal."

Simmons said she has always had a love for art but has only been seriously painting for about a year.

She described her paintings as telling stories of her experiences, particularly within the last two years, following a serious injury, being laid off from stable employment and being homeless living out of her vehicle.

"I lost my livelihood, I lost my home, I lost everything. I ended up in a truck with my dog and myself. (I went) from making \$4,000 to \$5,000 every two weeks, to nothing," said Simmons. "My painting is the sorrow, the tears of joy ... that's painting when I got out of the truck, that's painting throughout my journey and all my pictures have a story to tell and they're getting better."

Carment Erison, assistant director of library services for the Strathmore Library, is always excited for more people to be displaying their works within the library's galleries, at no charge to the artist.

"It's really a great, eclectic collection of paintings ... it's really quite stunning. She doesn't use a paintbrush, it's all done with her hands and with a knife and just her imagination really comes out on the canvas," said Erison.

Making his debut performance in Strathmore, Ed Hill is set to perform at Mike's Bar and Grill with a follow-up to his previous comedy special, Candy and Smiley.

Hill is currently touring across North America to explore new material for an upcoming special, which has yet to begin filming.

"I like to run it in as many places as possible, since different places may have different interpretations and reactions to it and I want to make sure that it remains consistent," said Hill. audience to laugh and be entertained, but also experience times of tragedy and levity.


Alongside speaking about the women close to him, Hill said he also talks about the effect his cultural and national heritage has had for him.



Strathmore U16 AA Ringette going to nationals

Strathmore's U16 AA Ringette team will be representing Team Alberta at the national tournament set to be hosted in Calgary next month.

The team's head coach, Wesley Clark, said although he is not surprised with the outcome of the team moving onto the national tournament level, he is excited for his team's success and the opportunity to compete at such a high level.

'We were ranked the No. 1 team in the province virtually all year and we've had a lot of success throughout the season," said Clark. "We won gold in St. Albert in October (2021), we won gold in Regina in November (2021). Unfortunately, we had a few tournaments cancelled."

Clark added his team went into the provincial tournament two years ago in similar standing and was unfortunately defeated in the crossover game following their round-robin.

This time around, Strathmore outscored the Calgary representative team in the gold medal game 11-4.

The team maintains a strong defense and penalty kill, something that Clark said enables them to create many more opportunities to score for themselves.

He said, however, that it is important that his team not think themselves invincible.

'We played four games and unfortunately in our fourth game we lost ... but that was a good thing because it always settles the nerves," explained Clark about their provincial games.

"If you can get a loss out of the way in a game that's not as important, then you can build off of that."

Though it has been a very positive season for Strathmore's U16 AA team, Clark explained it was not without its fair share of challenges.

These included disruptions caused by COVID-19 concerns both to the well-being of the team, as well as scheduled games.



Despite this, Clark added he is proud of his team and the leadership qualities they have displayed over the season.

"As a coach, I've been blessed with a team that works hard, they're dedicated and I know that they're one of the best teams that any coach could ask for," he said. "I don't like to single out any one or two players because we do play so well as a team. We have some girls who really step up in big games, but we're more of a team and it's not just about one or two players."

The The Canadian Ringette Championships (Nationals) will run from April 3 to 9 in Calgary. The team will spend the next few weeks in preparation, conditioning themselves to be able to potentially play more games in a shorter span of time than they are normally accustomed to.




