

Limiting license plate theft

The Strathmore RCMP are excited to announce the availability of security screws for license plates at the local detachment, firehall and auto retailers.

According to Sgt. Jay Salmon, the screws are part of a program to help reduce the theft of license plates, as a stolen plate is often used to veil a stolen vehicle.

"What the criminals will do is find a vehicle similar to the one that they have stolen and they will take the license plate off a non-stolen vehicle and put it on the stolen vehicle, so if we run that license plate it comes up as not being stolen and we just let the car go," said Salmon. "In regular traffic we would have no reason to stop it, it's not showing as stolen so it just a way that they can hold on to stolen vehicles a little bit longer."

By installing security screws on a vehicle it makes it significantly harder for a license plate to be stolen, thus aiding in the RCMP's ability to locate stolen vehicles.

Salmon said the process to get a security screw only takes a few minutes and has the potential to save a lot of headaches for local residents.

"So, what happens is, we basically swap out one of the little screws or bolts that holds your license plate onto your car with a security screw that needs a special bit to take it on and off. It just makes it harder for the bad guys to take the license plate," explained Salmon. "The biggest thing is crime prevention is what we are trying to do. Anything that we can do to help prevent those thefts from happening is a good thing."

A security screw can be acquired at the Strathmore RCMP detachment, at the Strathmore Fire Station or any local auto dealership, free of charge to the vehicle owner.

All a person has to do is go into one of those locations and request the installation of a screw. Salmon said this is not something a member of the public can do by themselves as the special bits needed to operate the screws are strictly controlled.

Should you ever need the licence plate removed, all you would need to do is take it back to one of the locations and have them remove the screw, also free of charge. "It's a new program, Staff Sgt. Wielgosz brought this over, he has done it in his previous detachments and has seen significant improvements in their criminal activities, so he has brought this idea to Strathmore," said Salmon. "It literally takes a couple of minutes and it can prevent hours of work. It protects the person as well because then they don't have to go to a registry to get a new license plate or anything like that."

Council begins exploring potential grant to help fund Redland water line

For the next 16 months, the Strathmore MunicipWheatland County Council is seeking more information regarding the logistics of potentially providing a grant to help fund a waterline for Redland residents.

Councillor Glenn Koester spoke at the May 3 regular council meeting on behalf of a delegation of residents from Redland.

"The residents of Redland are asking the County to grant the Wheatland Regional Corporation (WRC) \$75,000 ... Wheatland County has granted WRC approximately \$4 million in the past," said Koester. "WRC is experienced in putting in (water) lines and maintaining them. WRC would own this line and maintain it. This is a one-time grant, so the residents can enjoy water."

A letter written to County Council was included in the public agenda, it detailed that the requested waterline would be installed within the Hamlet of Redland on 1st Ave and 1st St E, which would provide equal access to residents.

Koester added during his presentation that the installation of the water line would do well to mitigate or solve water quality and quantity problems that the hamlet has been experiencing.

"Currently, Redland and area residents have experienced their wells going dry and there have been deeper wells dug in the area with poor water and supply problems," said Koester. "We have talked about this for three years. These residents, their wells are dry, residents in the area can't get water."

According to Koester's report, residents of Redland would be paying \$5.13 per cubic metre to the WRC for their water, post installation. The County rate is currently \$2.22 per cubic metre. The charge for Redland residents would be due to ownership and operation of the line by the WRC instead of the County.

If the line is installed by the WRC, the County will not be responsible for upgrading and maintaining it. Instead, that will fall to the WRC.

"There's not water in the (Rosebud) valley except this pipeline. WRC doesn't have the money to put in the pipeline, but the government has granted \$60,000 to get the main line there. All they are asking for is the \$75,000 to get it done," said Koester. "When it's done, WRC will oversee the hookups and they will be in charge of how the hookups are done. That is WRC's business and the homeowner's business."

Council defeated a motion to immediately approve the grant funding to the WRC, however, the discussion remains on the table.

Instead, Council has directed administration to bring a report back in June to discuss the options further and thoroughly explore the process before a grant is officially approved.

The letter that was received by council requesting the grant, had requested a timeline of seeing the water line completed in Redland by June.

Wheatland County adjusting agreement with Marigold Library System

Wheatland County is has signed off on amending its operational agreement with the Marigold Library System, which updates some of the language of the agreement and the organization's levy rates.

The Marigold Library System wrote a letter to council requesting a decision on the matter by Sept. 30. Council reviewed the letter during the May 3 general meeting.

Michelle Toombs, CEO of the Marigold Library System, said as much as the library system has tried to keep changes to a minimum, it is time for an update to keep up with financial demands and modernize the language of the agreement.

"The Marigold Agreement has not changed a lot, although it has been revised recently. The last revision before that was in 2008 and it's very much patterned on the libraries act," said Toombs. "It is our obligation, when a county does not have its own library board, to represent and provide servictem is the third largest library system in Alberta, serving approximately 348,000 people across 43 member municipalities


The letter to council documented the revision to the agreement and discussed a request for review and consideration of adjusting to a new schedule for levy rates in 2023 and 2024

"We have always calculated our levies, which is the revenue that we get from municipalities, on a per capita basis that is based on population," said Toombs. "For the last three years, we have not increased our levies ... but now we are seeing the pressures of inflation, fuel costs (and) utility costs ... so we have asked for an 11 per cent increase in our levy rates."

BBB Scam Alert: Watch out for "free roof inspections" BBB



With the warmer weather and summer storms oofing scams become more common. <u>BBB Scam</u> Tracker frequently receives reports of shady "free of inspections. Homeowners should be on the ookout for these cons

You receive a call or a person shows up at the door claiming to represent a roofing company According to Scam Tracker reports, con artists often use the name of the place (i.e. Calgary or Strathmore) plus "Roofing" or "Construction" as their business name


The "roofer" offers a free inspection. Why, you ask? The person may claim that their company is working on a neighbour's home and is offering inspections to those living nearby. But if you ask questions about where the business is located or how their services work, you'll most likely be met with vague answers, or, if you are speaking on the phone, they may simply hang up.

You accept the free inspection, and the "inspector" shows up at your house. If they don't find nous because and tear to merit a whole new roof, they may fabricate it, by tearing off shingles to mimic wind damage. Or they may simply show you pictures of someone else's damaged roof. Don't hire this company! Any repairs done by such a dishonest business are not likely to be high

How to avoid roofing scams:

- · Beware of unsolicited offers. Most scams begin with a contractor who "just happens to be in the area" and notices your roof or home has the appearance of needing repairs from the outside. Roofing scams typically increase in frequency after a powerful storm, so stay alert
- · Get your insurance company to inspect your roof. Filing a claim with your insurance company goes on your record and could affect future claims or your continued coverage. Before signing any paperwork or contracts with a roofing company, have your insurance company to come out for an inspection to verify the need for repairs or replac
- Research roofing companies before you hire. Look at a company's business rating on BBB.org. Keep a close eye on previous reviews and any complaints other consumers might have had. This is one of the best ways to know if a roofing company is reputable or just a cover for a scam.

Calgary Stampede First Nations Princess crowned

Sikapinakii Low Horn will be representing Siksika Nation, as well as her family tipi, as she has been crowned the Calgary Stampede's First Nation's Princess for 2022.

Low Horn was crowned with the title alongside Jenna Peters, who was named the Calgary Stampede Princess.

"It's been very busy, but (Jenna and I) are both enjoying the things that have come our way," said Low Horn. "I get to work alongside Jenna, but as well go to the different nations of Treaty Seven. I think the big thing that I look forward to is engaging with the youth of Treaty Seven and building that relationship."

Peters added this year is slightly different for the Stampede. Typically, Stampede royalty consists of a queen, two princesses and the First Nations Princess. This year, it is just Low Horn and herself.

"I think it's a step forward in reconciliation and so, for us, I think it's just being strong ambassadors for the Calgary Stampede," said Peters. "It's very exciting, it's kind of been a whirlwind already and we've hit the ground running. We have had a couple of events and our schedules are getting jam-packed, but I think we are both really excited to be representing our cultures and represent the Calgary Stampede."

According to the princesses, their two roles are slightly different, as were the three weeks of competition they participated in prior to their coronation.

Peters explained she and Low Horn began with several competition segments together, including a speech clinic before separating to conclude the pageant.

"We have interviews, there are several mix-and-mingle (events) where there is a room full of secret judges, so you have to interact with everyone and try to let your personality shine and be your authentic self," said Peters.

Low Horn shared similar experiences.

"For the First Nations princess, it's kind of the same process, but a little different. We showcase our cultures and our knowledge on the history of Stampede with the First Nations people," explained Low Horn. "We do a speech as well, we do impromptu questions and we do our dancing."

For her, Low Horn said being crowned princess is an ex-

"I also have my Low Horn family and my Duck Chief family and so being able to carry those names and represent them means a lot to me," she said. "I want to be the best role model that I can be for indigenous youth as a whole and be able to relay a positive message ... I want to encourage Indigenous youth to really follow what they want and to not be shy, to not be scared."

The Calgary Stampede is scheduled to take place this summer from July 8 to 17.

According to the new agreement, the "Ownership of Property," section was changed to state books, periodicals and library materials transferred to a member library by Marigold will remain the property of that library or municipality, rather than the Marigold Board.

Another change was the reference to the Government of Alberta for current municipal populations. The reasoning for the change is due to the responsibility for reporting populations has shifted from the Municipal Affairs to Treasury and may be subject to future changes.

Language was also added to strengthn the importance of the munic member collaborative and expanded service descriptions were added to clause 28 in the revised agreement (establishment and maintenance of a library system service for residents of parties within the agreement and which services are provided). A statement was inserted to allow Marigold to negotiate a separate service contract with a governing entity that is not covered by the Libraries Act, such as a First Nations reserve or Redwood Meadows, found in clause 41. A copy of the agreement is publicly available through the Wheatland County Council agenda for May 3 and any questions or concerns are able to be directed to the Marigold Library System.

Two local trick riders to perform at Ponoka Stampede

Local trick riders Mackenzie Jensen and Jayna Hale (17) have been invited to perform at the Ponoka Stampede this summer.

The Ponoka Stampede is regarded as the second-to-largest rodeo event in Alberta, following the Calgary Stampede and it will be the girls' first time being asked to perform there.

"You put your bid in (to perform) and they choose. Usually, there is more than one group that wants to be there, so they just choose who they think is the best suited for the job each year," explained Jensen who added that trick riding is a sport that is not for the feint of heart, as it is a demanding and timeconsuming sport to be able to do both well and safely.

"Me and Jayna practice together once a week and we also ride every single day to keep ourselves and our horses in condition," said Jensen. "It takes a lot of determination and hard work. You have to be in good physical shape and willing to ride your horse every day, so they are in good physical shape. You have to not be too scared of stuff."

Jensen started trick riding when she was five years old, being introduced to the sport through regular exposure to rodeo. She suggested that she was bored with riding normally and wanted something a bit more exciting.

Hale started at a similar age and has been in competition since she was nine — claiming three Canadian championships, a reserve north American championship and several competitions based out of Calgary.

Jensen has also been awarded several Canadian titles and is the reigning two-time North American Champion.

"I also grew up in rodeo and I actually got invited to a clinic by a friend of ours, so I decided to try (trick riding) and I really liked it," said Hale.

Trick riding, Jensen explained, is a sport that takes daily dedication to both maintain one's own physical shape, as well as to build trust with the horse.

"Finding motivation to not just ride, but workout and stretch every day, eat right and have a good routine — it's pretty challenging," said Jensen.

Typically, Jensen and Hale will spend at least an hour each day riding and working with their horses.

The two youths explained they attended school together and had ties with each other's families, adding it just made sense to begin riding together.

Regarding their invitation to perform in Ponoka, Jensen and Hale explained it is an intimidating prospect, but among the rodeo season it is certainly something they are excited to be a part



of. Similarly, it will be the largest stage the two have taken to performing at.

Having both received their professional accreditation from the Canadian Professional Rodeo Association, Jensen and Hale are looking to achieve performance goals throughout Canada and in the United States for the upcoming season.

The girls will also perform in Taber, Lea Park, Grande Prairie, the Stompede, TeePee Creek, and the Strathmore Stampede this season, among other shows.

Running With the Bulls set to return for Stampede

Running With the Bulls is scheduled to make its return during this year's Strathmore Stampede for another round of excitement.

Kate Dubois, events coordinator with the Strathmore Agricultural Society, said as one of the Strathmore Stampede's main attractions, it never fails to gather a large crowd both to watch as well as to participate.

"Everything should be running the exact same ... there will be another \$1,000 prize for both Saturday and Sunday night and if you decide to pre-register, you do get a free ticket to our Saturday Cowboy Cabaret," said Dubois who joked that also included in the prize is a belt buckle and bragging rights.

The winner of the event is chosen by crowd favourite as the bravest, or most insane runner in the ring.

It was estimated that last year's event nearly sold out of running slots for folks registering to test their mettle on both days of Running With the Bulls. For spectators, it is also expected that tickets won't be available for a long time prior to selling out.

"Our Saturday and Sunday nights are always a sell out, especially for chuckwagons and Running With the Bulls, so definitely buy your tickets early because they go quick for those nights," said Dubois.

She added the Strathmore Stampede will also continue to follow all AHS guidelines that are in place during the event. In case there are updates to public health mandates, the team behind the Strathmore Stampede is committed to keeping their fans up to speed regarding the event.

According to Dubois, Running With the Bulls has been a part of the Strathmore Stampede since 2003, and has continued to grow since its inception.

"More and more people are seeing it and hearing about it and it is pretty rare to find this in Alberta, so it has definitely grown since then," said Dubois. "All over our social media people have been excited. People are still definitely a little hesitant, I think, to run with them, so I definitely recommend getting in and it's a super great time."

For those in the back who have yet to hear about Running With the Bulls, the event is comprised of three rounds, progressively upgrading to more experienced bulls into a ring full of people.

Contestants are not allowed to intentionally harm the bulls but are allowed to provoke them before attempting to not get trampled.

"It's typically an impulse thing. It definitely takes some encouragement from your friends to register, but we applaud those who preregister," said Dubois. "They start off with the easier bulls and then they add the meaner, tougher bulls and it gets more and more exciting."

Local Athlete to play in Team Alberta Senior Bowl

Football Alberta is once again hosting their annual Senior Bowl High School All-Star Game for graduating Grade 12 students and one player from Strathmore will be participating.

Matthew Oslanski was among the 40 players selected to participate on the South Team following the final camp from April 20-22.

According to Oslanski, the final selection was a three-day camp which consisted of two practices per day, followed by a scrimmage on the final day.

"The first day was pretty bad because it was Friday in Calgary and it was a

snowstorm. We had to play in slush and it was super wet, not really fun to do stuff," said Oslanski. "I didn't do too well that day, but then Saturday and Sunday I picked it up and did way better."

Among the 150 athletes trying out, Oslanski and one other were the only applicants from Strathmore.

The North team would be comprised of players pulled from schools north of Red Deer, while the South Team is made up of players from south of that dividing line.

Oslanski said the competition was tough to pass selection for the team, as the other applicants were among the best graduating players in South Alberta.

The South Team will have six practices over three days together during the May long weekend, prior to the game on the Monday.

While playing in Strathmore, Oslanski was a wide receiver, and will play the same roll on the South Team.

Oslanski said he has been playing football since Grade 7 after a friend had encouraged him to try it out. Having been playing hockey at the time, Oslanski hung up his skates and traded them for cleats.

"I just love the environment of football, especially camps like this where most people are friendly," he said. "It's a very good way to learn leadership and how to be good with other people and work with other teammates."

Post high school, Oslanski plans to play junior league football, then university level if he receives an offer to do so.

Oslanski has thus far received an offer from the Okanagan Sun in Kelowna, B.C. to play. He said the offer came following his acceptance to the South Team for the Senior Bowl.

"The (purpose) of the Senior Bowl and Team Alberta and all this is mainly for exposure for players to get looked at by scouts," he said. "For example, the Calgary Colts are a Junior (League) team in Calgary and they are the ones who ran the camp this weekend."

The Senior Bowl game is scheduled to be played on May 23.

Local martial artists to compete on national stage

Several young martial artists who train in Wheatland County are preparing for a trip to Ottawa to compete on a national stage.

Sensei Tammy Thankachen, owner of Oku Damashi Martial Arts, said seven of her students qualified in March to compete in Ottawa on Alberta's karate team.

"I'm so proud, words cannot convey how excited and proud I am of them ... most of them are quite new to the tournament circuit," said Thankachen. "Being closed for COVID-19, we had to (train) through Zoom and that was super tough on the kids. Martial arts is a hands-on type of sport so it was very difficult for the kids to maneuver their way through it."

Logan Alce (17), Mateo Orr (10), Nathan Mutlow (9), Miara Robinson (9), Gemma Alce (9), Kaiya Robinson (12) and Zoe Neufeld (12) comprise Thankachen's roster of students headed to Ottawa from May 20-22 for nationals.

During the provincial tournament in Edmonton on March 19, those seven students claimed a total of 19 medals for their dojo.

Thankachen teaches a style of Karate called Goju Ryu, which is a traditional Japanese form of hand-to-hand combat.

The term "Goju" means "hard and soft" referring to use of both hard and soft techniques. Many of the origins of the style (ryu) come from Okinawa.

Thankachen explained that for most of the students who qualified for Team Alberta, it was their first time entering the tournament scene.

"They committed, they were training in the dojo for four or five times a week for two or three hours a day. They worked hard, they were put through the ringer and some pretty grueling training sessions," said Thankachen. "It was tough for them but they really toed the line and stepped up and really wanted to fulfill a dream of theirs, so they all worked hard. We took the team up to Edmonton and all seven of them

detailed choreographed patterns of forms) and sparring. This will also be the case when they go to compete in Ottawa.

Based on their success in Ottawa, Thankachen's students may be offered the opportunity to compete at worlds in Dublin, Ireland this October.

"There is always stuff to learn and really improve on. That is one thing, we are always trying to perfect our art and ourselves with it. For the kids, a lot of it is getting over those nerves and the fear of the unknown," said Thankachen. "They have to fine tune all the small things, but they are ready, they are motivated, and they look really good right now."

Logan Alce was the only student to have previously competed at the provincial and national level. He has also qualified for Team Canada's youth Muay Thai team and will compete at worlds in Calgary in August.

Strathmore Ag Society announces construction of local horseshoe pits

The Strathmore and District Agricultural Society (SDAS) has both received funding for and will be constructing horseshoe pits within the Ag grounds this summer.

According to SDAS CEO Ryan Schmidt, the idea was one brought forward by and significantly advocated for by a community member, prior to approval.

"I have to give a lot of credit to a community member who took the initiative to get somebody to build horseshoe pits ... we took this to our board and discussed it and found a great spot for the horseshoe pits," said Schmidt. "There will be eight horseshoe courts and a storage shed and we should have those up and running probably in June. We're very thankful to the New Horizons for Seniors program which awarded us a \$20,000 grant to build them."

The game of horseshoes sees players throwing horseshoes at a stake in the ground from a distance of 40 feet. Points are scored by players whose horseshoes are closer to the stake than their opponents' so long as they are within six inches

of the stake.

The pits will be placed just north of the baseball diamonds with access through the walkway to the baseball concession and washrooms.

According to Schmidt, there is also an opportunity for hosting competitions once the pits are fully constructed.

"There is actually an Alberta Horseshoe Pitching Association with leagues all over and they actually have a provincial championship, (and) a Western Canadian championship," explained Schmidt. "We would also like to open it up to having a youth night and a senior's night where people come and try it out for free, but obviously, the league will be running as well at the site.'

The project was funded through the New Horizons for Seniors program, which was awarded to the Agricultural Society.

"One of the benefits of the horseshoe pits is they will be available to campers, including those campers at the Strathmore Stampede as something extra to do while they are staying at the grounds," said Schmidt, who expects the project to be moving forward very soon.






